Minutes of the Board of Supervisors Regular Board Meeting held October 20, 2014.

1. Meeting called to order by Chair Humphrey at 4:03 p.m.

A. Approval of Agenda: **Motion by Supervisor Behrens and Supervisor Willems seconded** to approve the revised agenda. Motion carried unanimously.

B. Announcements: The Board was sent a list of upcoming meetings in the board packets. **Motion by Supervisor Behrens and Supervisor Willems seconded** to approve the following as a Special Other Meeting: MACD, November 13, 2014 from 9:00am-2:30pm at Cabella's 20200 Rogers Drive, Rogers, MN. Motion carried unanimously.

Motion by Supervisor Willems and Supervisor Behrens seconded to move the December Board Meeting to Monday, December 15, 2014 due to a conflict with the MASWCD Annual Conference. Motion carried unanimously.

2. Public Meeting for Feedback on Draft Redistricting Maps: Supervisor Humphrey explained that the legislature passed a bill in 2014 that will require all seven metro SWCDs to transition Supervisor elections from Countywide to elections by District. Two draft maps were available for review and both had been reviewed by Ramsey County Elections, as well as the Ramsey County Attorney's office. Ann further explained the review completed by Joseph Mansky, with Ramsey County Elections and that both plans meet the statutory criteria provided by MN State Statute 103C.311, subdivision 2, as both plans are substantially equal in population, reasonably compact, contiguous territory, numbered in a regular series, and based on existing municipal precinct boundaries. The plans also comply with US Supreme Court criteria for traditional districting as not unduly advantaging or disadvantaging any of the current board members, compliant with requirements of the Voting Rights Act to create opportunities for representation by members of minority groups, and minimizing splitting political subdivisions to the extent possible.

Supervisor Humphrey asked for any comments on the draft plans. One plan has the City of Roseville split between two Districts and the other plan has the City of Maplewood split between two Districts. Mr. Gardner commented that because both Roseville and Maplewood have substantial populations, that splitting these cities was unavoidable with five Districts. He stated his preference for aligning the Districts with the seven County Commissioner Districts, which is an option within the new legislation. Mr. Petersen echoed the preference for going to the seven County Commissioner Districts. He also requested that the maps be published in a newspaper to allow public comment. Ann will post them on the RCD website. The board decided by consensus to wait to vote on the maps until the November board meeting.

3. Staff / NRCS Reports: The staff updated the board on recent projects and activities. No report from NRCS.

4. Approval of Standing Reports:

B. Treasury Report – Abbreviated 3rd Quarter 2014 Report

Ann explained that most likely the RCD will finish 2014 at a deficit and that it is almost entirely because of the decrease in Ag fees collected for 2014. **Motion by Supervisor Behrens and Supervisor Anderson seconded** to approve the 3rd Quarter 2014 Abbreviated Treasury Report. Motion carried unanimously.

D. 2014 MASWCD Resolution Ballot Approval: Supervisor Willems, who is on the MACD Resolutions Committee, asked if there were any questions on the resolutions and turned in her ballot, which is due to the MASWCD by November 1st. The other board members will send their ballots to the RCD office prior to the deadline. **Resolution 14-10-04**. Supervisor Willems moved and Supervisor Behrens seconded. Resolved the Board approved submitting the composite ballot to the MASWCD by the November 1, 2014 deadline.

E. MASWCD Annual Convention: Supervisor Willems expressed interest in attending the MASWCD Convention, particularly on Tuesday for the resolution discussion. The Board will vote to approve the meeting at the November board meeting.

F. 2012 CWMA Cost Share Reimbursement: **Resolution 14-10-05**. Supervisor Willems moved and Supervisor Behrens second. Resolved the Board approved the following:

The MN BWSR had provided \$15,000 in FY12 CWMA funding to the RCD for the cooperative control of invasive species within Ramsey County; and

Whereas, the BWSR approved \$5,000 of the grant for administration and technical assistance and \$10,000 of the grant for cost share for the control of target species;

Be it further resolved, the Ramsey Conservation District Board authorized the encumbrance of \$4,590.40 in FY12 CWMA Grant to the City of Roseville to treat four emerging invasive species (Japanese knotweed, Tansy, Japanese hedge parsley, and Oriental bittersweet) on Roseville property:

Now Therefore Be It Resolved, the RCD Board agreed to approve reimbursement payment of \$4,590.40 to the City of Roseville, Parks and Recreation.

Contract# CWMA-4, Total Project Cost: \$6,121.00; BWSR CWMA eligible components 75%, \$4,590.40; City of Roseville component 25%, \$1,530.60.

G. BWSR 2012 Verification: The Board reviewed the letter from BWSR regarding the 2012 Verification, as well as the response letter sent by the RCD. Ann commented that the process took approximately 40 hours of work and was quite an extensive process, but all LGUs that received Clean Water Legacy funding in Ramsey County, such as Watershed Districts and Water Management Organizations, also went through this verification.

H. BWSR 2011 Native Buffer Project Reimbursement: **Resolution 14-10-06**. Supervisor Behrens moved and Supervisor Anderson second. Resolved, the Board approved the following:

The MN BWSR has provided \$90,000.00 in FY11 Native Buffer Cost-Share funding to the RCD for the restoration of eroded shorelines on lakes within Ramsey County; and

Whereas, the BWSR cost-share shall not exceed 75% of the total construction cost and the RCD shall utilize 20% of the BWSR cost-share grant for technical and administrative costs incurred by the RCD staff; and

Whereas, the RCD Board of Supervisors designates, Joe Lochner, as the technical representative for these projects, as Ryan Johnson is no longer District staff;

Now Therefore Be It Resolved, the RCD Board approved reimbursement payment to the following:

Ramsey County Parks and Rec: Keller Golf Course (Paul Diegnau) at 2166 Maplewood Drive, Maplewood, MN 55109 for a native restoration on Phase II.

Contract # NB-FY11-4, Conservation Practice 342, 643; Total Project Cost: \$26,542.92; BWSR Cost Share of Eligible Components 75%/\$19,907.19; Technical and administrative reimbursement to the RCD shall be 20%: \$4,976.79.

Whereas, the RCD Board of Supervisors designates, James Landini, Washington Conservation District Staff as the technical representative for these projects.
