RULE 20 Overview



What Is Competency To Stand Trial?

A person may not plead, be tried, or sentenced if they lack the ability to:

- Rationally consult with counsel
- Understand what is happening in court and
- Participate in their defense because of a mental illness or cognitive impairment.

This would violate their rights to a fair trial.


Competency Motion and Examination

- The judge, or either attorney raises the question of a defendant's competency.
- Proceedings are suspended.
- The judge orders a competency examination.
- This examination:
 - must be completed within 60 days
 - may take place in the jail, out-of-custody in the community, or in a hospital
 - must be done by a court appointed psychiatrist or psychologist, called a "court examiner."
- The examiner reports their opinion back to the court and the judge decides.

Incompetent to Stand Trial

- Charges are suspended (some may be dismissed based on level and time)
- Civil Commitment proceedings start
- New court (civil), new judge, new county attorney, new defense attorney (if public defender)
- A person can go a lot of a different ways from here

- Two elements to competency restoration:
 - Mental Health Treatment
 - Competency Education



The Gaps

- A person is incompetent, but does not meet the standard for commitment
- A person is committed in the community where there are no competency restoration programs
- A person is committed inpatient to a DHS hospital (Anoka, or Forensic Services in St. Peter) but they are provisionally discharged before they regain competency

The Issues

- People sit in jail
- It's hard to find or maintain placements
- There is no competency restoration in the community
- We "lose" people in the community either before examination or if they do not meet the standard for commitment
