

### Career Opportunity: Assistant Deputy Director – Field Services

Ramsey County Community Corrections is seeking an Assistant Deputy Director for its Field Services Division. This is a full-time hybrid position with oversight at two different locations. The locations are Downtown, St. Paul at Metro Square and East side of St. Paul, at 800 Minnehaha. The salary range for this benefit-eligible position is \$92,958.27- \$138,162.83 annually.

# About Ramsey County Community Corrections

The 470 employees of Ramsey County Community Corrections provide services to more than 10,000 justice involved clients. This work is supported by three divisions:

- 1) The Administrative Services Division, which provides fiscal support, strategic planning, research and evaluation, information technology, human resources management, quality assurance, and contract development.
- 2) The Facilities Division, which oversees the Ramsey County Correctional Facility (RCCF) and the 44-bed Juvenile Detention Center.
- 3) The Field Services Division is comprised of Adult Services, which provides pre-trial, parole and probation services to clients who are 18 years or older. Juvenile Services, provides probation services, monitoring of clients on conditional release pending court, and electronic home monitoring services to youth and young adults aged 10-24.

Ramsey County is committed to putting well-being and community at the center of its justice system transformation and we are nationally recognized as being at the forefront of reform efforts. We are guided by a strategic plan that focuses on four major goal areas: 1) One Client, One Plan, 2) We Reflect the Clients and Communities We Serve, 3) We Communicate and Engage, and 4) More Community, Less Confinement.

We foster safe communities by helping clients reduce their risk to reoffend. We work to identify and respond to each client's individual risk factors, needs and strengths. We support clients in the development of skills that help make long term changes and leads to successful completion of their probation. We are committed to:

- Collaborating with clients to develop supervision plans that address the behaviors that put themselves and others at risk.
- Helping clients access needed mental and chemical health services, educational supports, and cognitive. behavioral programming to reduce problematic and violent behavior.
- Working with our community partners to enhance capacity for client services.
- Offering restorative justice services so clients can address the harm they caused to victims and the community.
- Partnering with community to build trust and to collaborate on system reform.
- Collaborating with our judges and other justice system stakeholders to address decision points that contribute to system inequities and disparities.

#### **About This Role**

This position is one of four Assistant Deputy Director positions within the Field Services Division and assists the Deputy Director of Field Services in the management and supervision of the division. The current vacancy is in Adult Services. Responsibilities include:

- Practice and support the goals and priorities of the Department and Division
- Overseeing the day-to-day operations of the division
- Coaching, supporting, evaluating and supervising up to 10 supervisory staff, each with up to 12 direct reports.
- Maintaining and monitoring fiscal, program and service provision accountability
- Formulation, implementation and oversight of division goals and outcomes

- Managing in a union-represented environment
