Title: Approval of 2021 Capital Improvement Program Budget and

Financing

Background and Rationale:

The Home Rule Charter for Ramsey County, Chapter 10, Section 10.01 (a) (2) and Section 10.05, require Ramsey County to prepare a five-year Capital Improvement Program plan and Capital Improvement Program budget for the ensuing fiscal year.

On September 3, 2021, the Budget Committee of Whole met to review the Supplemental 2021 Economic Growth and Community Investment Budget and to hear of potential changes in the Capital Improvement Program plan and budget as proposed by the County Manager and the Capital Improvement Program Citizens Advisory Committee (CIPAC).

On November 5, 2020, the CIPAC recommended approval and adoption of the 2021 Capital Improvement Program Budget and Financing.

Staff are requesting the approval and adoption of the 2021 Capital Improvement Program Budget and Financing with additional changes approved by the CIPAC during its November 5, 2020 meeting.

Recommendation:

The Ramsey County Board of Commissioners resolved to:

Approve and adopt the 2021 Capital Improvement Program and Budget Financing including the following changes:

- 1. An Affordable Housing Investments Project will replace the Golf Study Project in the 2020 Capital Improvement Program plan and budget for \$3,677,311 and in the 2021 Capital Improvement Program plan and budget for \$2,432,935.
- 2. Funds from the Library Operating Fund Balance will replace the bond proceeds for the Maplewood Library Remodel Project for \$2,769,005.
- 3. The original proceeds from the Maplewood Library Remodel Project will be reallocated to the Affordable Housing Investments Project.
- 4. The Highland Arena site improvements project replaced the Highland Parking Lot project for \$1,900,809 which was approved on County Board Resolution 2020-166, September 1, 2020.
- 5. The Public Works projects in the 2021 Capital Improvement Program plan and budget are reduced by \$1,224,000 as this funding from Wheelage Tax revenue is moved to the Supplemental 2021 Public Works operating budget.
- 6. The Public Works road projects in the 2021 Capital Improvement Program plan and budget are reduced by \$2,000,000 from the reduction of County State Aid Highway funding
