




# **Historical Background**

Creation of Bail Reform Workgroup (BRWG) and System Changes

## **BRWG History**

- Community asked system stakeholders to do more to reduce pretrial detention, BRWG formed (2019).
- Ramsey County selected as research action site with Advancing Pretrial Policy and Research (APPR). Funded by Arnold Ventures (2020).
- Ramsey County contracted with Research in Action to assist in community engagement and the codesigned process (2021).

### **Goals of Bail Reform Work Group**

Eliminate the harm to communities caused by the for-profit cash bail system while improving public safety and court appearances by:

- Transitioning from a system based on wealth to one based on risk.
- Reducing the reliance on the cash bail system.
- Ensuring no one is held because of an inability to pay.
- Reducing the jail population.
- Increasing court appearance rate.
- Engaging community members to develop and be part of system alternatives including, but not limited to, a pretrial assessment tool.
- Orienting systems around promoting community safety and wellbeing.



## **Bail Reform Work Group Structure & Tasks**

#### **Executive Committee**

- Environment for key leadership to receive updates on progress.
- Respond to and bring forward any important issues and make key sponsor-level decisions on project direction.
- Provide input into the agenda for the Bail Reform Work Group meeting.
- Provide recommendations or make ultimate decisions about key things that are not addressed in the Bail Reform Work Group meetings.

#### **Bail Reform Work Group**

- Actively participate in codesigning the new pretrial process.
- Provide direction and input to the Bail Reform Sub committees.
- Monitor implementation of the Public Safety Assessment.

#### **Sub Committees**

- Data.
- Communications.
- Pre-Charge Process.
- Coordination Team.



## **BRWG History and Design Work**

 Conducted three town halls with stakeholders, justice-involved individuals and other community members.

#### – Town Hall Topics:

- Pretrial Process (booking) experience and needs (2022).
- Pretrial Assessment Tools (2022).
- Community Supports (Navigators) (2022).
- Analyzed jail and system data to identify opportunities for improvement (ongoing).
- Ramsey County Public Safety Assessment (PSA) pretrial assessment tool validated (2023).
- Adult Detention Center data dashboard developed (2023).

## **Community Recommendations**

- Establish a team/office of Navigators to help guide folks as they move throughout the pre-charge process.
- Utilize existing community and organizational support networks and resources for those who are navigating the pre-charge process.
- Ensure implementation and practice of the Public Safety Assessment (PSA) remains transparent and holistic for its users.
- Improve legal and educational resources and support for those who are navigating the pre-charge process.
- Establish logistical resources and support for those who are experiencing reentry prior to a hearing.
- Establish better and accessible resources and support for basic health needs throughout the pre-charge process and after release.
- Consider alternatives to incarceration.

# **Changes Already Made**



## **Changes Already Made**

#### **Elimination of Fees**

- The Sheriff's Office eliminated a \$25 booking fee at the Adult Detention Center (2017).
- No medical cost for those in custody at the Adult Detention Center. Previously charged for: Doctor, Nurse and Dentist visits; Prescription and over-the-counter medication (2019).
- Phones fees reduced for the Adult Detention Center (2020).
- Pretrial services vendor no longer charge for services (2021).



## Other Changes Already Made

Courts delegate release to pre-trial services vendor to have some individuals released prior to a court hearing (2006).

Community warrant resolution days held to resolve warrants without jail time (2017-2019).

County Attorney expands diversion to pre-charge (2019).

Saint Paul City Attorney makes pre-trial improvements, including empowering prosecutors on weekend duty to release people when there is no need to hold them (2020).





## **Proposed Process**

- Adult Detention Center Staff and Justice Point Screen for Eligibility.
- Released with Community Support.
- Charging Decision:
  - Dismissal.
  - Pre-Charge Diversion.
  - Court Date Summons.

## **Eligibility**

#### **Arrest Crime**

 Low-Level Nonviolent Felony and Gross Misdemeanor Property and Drug Crimes.

#### **Pretrial Assessment**

- Public Safety Assessment (PSA).
- Discretionary Guidelines.

## Public Safety Assessment (PSA)

#### What is a Pretrial Assessment?

An actuarial assessment that estimates the likelihood that someone will succeed pretrial by making future court appearances and remaining arrest-free while pending case disposition.

## What Is the Public Safety Assessment?

- An assessment tool that was developed using a large national data set (750,000 cases).
- Validated locally in Ramsey County.
- Shown to be highly predictive in Ramsey County without indication of systematic racial bias.

# **Community Supports**

## **Community Supports "Navigator"**

The community requested and the county will fund a community-based support "Navigator" to work with individuals who want additional support.

Navigator will assist individuals with resources to meet basic needs and provide supportive services as the individual moves through the pretrial process.

Services can include the transportation cost to and from court, clothing, food, childcare and other services/referrals identified by the Navigator.

# Sequential Bail Review

## **Sequential Bail Review**

**Sequential bail review** is the process of reviewing the status of pretrial detained defendants held in-custody on a regular and ongoing basis.

- Determine if there have been any changes to request review of custody status.
- Helps to minimize the jail population.
- Results in better outcomes across the justice system.

# Performance Measures and Accountability

## Why Measure Performance?

- To ensure accountability our goal is to examine racial equity in each selected measure.
- To ensure we are operating faithfully to the design and consistent with identified best practices.
- To ensure we are on track to meet goals and objectives.
- To provide feedback necessary to continuously improve.
- To document our results for long-term sustainability.

#### **Some Proposed Performance Measures**

1. Pretrial Population

# of people arrested through a custodial arrest or citation/summons for a new jailable offense

2. Pretrial Release Population

# of people released during the pretrial period (not in jail, but released to the community)

3. Pretrial Release Rate

% of pretrial population who released or in the community while awaiting case disposition

4. Court Appearance Rate

% of people who were not issued a warrant for failure to appear (FTA) during pretrial release

5. Arrest-Free Rate

% of people who were not arrested for a new jailable offense during pretrial release

6. Violent Arrest-Free Rate

% of people who were not arrested for a new jailable violent offense during pretrial release

7. Detained Pretrial Population

# of people in pretrial detention on any given day

All measures will be tracked by race and evaluated for equitable outcomes.


#### **Bookings Over Time By Race**



## **County Allocated Resources**

- Community Supports (\$1,000,000 over 4 Years)
  - Community-Based Navigator.
  - Engagement Events (Town Halls & Bail Reform Work).
  - Support Costs.
- Staffing Resources (\$750,000 over 4 Years)
  - 1 Full time person to the Office of Safety and Justice.
  - 1 Full time person to the Sheriff's Office.
- Data Support, Website and Maintenance (\$280,000 over 4 Years)
  - Bail Reform Data support.
  - Adult Detention Center web base Jail Roster development.
  - Adult Detention Center Data Dashboard maintenance.
- Adult Detention Center Phone Fees (\$1,600,00 over 4 Years)
  - Sheriff Office exploring ways to reduce or eliminate phone fees.
