The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### **COUNT I**

Charge: Obstruct Legal Process-Interfere w/Peace Officer

Minnesota Statute: 609.50.1(2), with reference to: 609.50.2(1)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 03/04/2017

Charge Description: On or about March 4, 2017, in the County of Ramsey, Minnesota, Anton William Bueckert intentionally obstructed, resisted, or interfered with a peace officer while the officer was engaged in the performance of official duties, and caused substantial bodily harm,

Charge: Use Tear Gas to Immobilize - Not Protect Self/Property

Charge: Riot-3rd Degree-Unlawful Force or Violence

Maximum Sentence: One year or \$3,000 or both.

Charge Description: On or about March 4, 2017, in the County of Ramsey, Minnesota, Anton William Bueckert, with three or more people assembled, disturbed the peace by an intentional act or threat of unlawful force or violence to person or property

## 62-CR-17-3774 STATEMENT OF PROBABLE CAUSE

Your complainant is Sergeant Eric Zastrow, an investigator with the Minnesota State Patrol. He states that the following is true, correct, and establishes probable cause:

On March 4, 2017, a permitted rally took place at the Minnesota State Capitol in Saint Paul, Ramsey County. During the rally, protesters arrived at the Capitol. Most were peaceful but some (more than 10) were wearing face and head coverings, and wearing goggles. At about 12:45pm, a Minnesota State Trooper was watching the crowd on the west stairs leading to the rotunda. The trooper, identified in reports, saw a male, later identified as Anton William Bueckert, spray several people with a tear gas compound. Bueckert ran up the stairs to the second floor. The trooper was unable to give chase due to the crowd on the stairs.

About thirty seconds later, the trooper saw Bueckert run back down the stairs, pushing through the crowd and punching people at the bottom of the stairs. The trooper grabbed Bueckert and informed him he was under arrest. Bueckert fought and resisted but the trooper, with assistance of a Capitol Security Officer, was able to arrest Bueckert. After indicating he had not intended to be arrested that day, Bueckert decided to remain silent.

Multiple people, identified in police reports, described being sprayed with a tear gas compound in the area of the stairs that day. Two people, identified in police reports, had to be treated by paramedics for the effects of the tear gas.

The trooper was injured during the arrest of Bueckert and later discovered that he had fractured his thumb. Minnesota Statute section 609.02, subd. 7a defines "substantial bodily harm" to include a fracture of any bodily member.
