

# SCHOOL ATTENDANCE MATTERS (SAM)

Students who frequently miss school fall behind. We collaborate with students, families, schools, law enforcement, community agencies and child protection staff to improve school attendance.

Our goal is to understand the reasons children are missing school and work with students and their families to remove those barriers so they are present every day and succeed in school and in life.

## WHAT WE DO

• An Assistant County Attorney meets with parents of children (and children 12 and older) to discuss the lifelong benefits of education and educate parents on the compulsory education law and the steps we take to enforce it.

## GOOD NEWS! 79% of students improve their attendance after this step!

• If attendance does not improve, parents (and children 12 and older) are given the opportunity to participate in a Student Attendance Review Team (SART) meeting, during which we create a contract to address the reasons for the child's absence.

• If attendance still does not improve, the County Attorney may bring the matter to court. If a child is under 12, legal action will be taken against the parents. If a child is 12 or older, legal action will be taken against the student, the parents, or both.



## **EVERYONE HAS A ROLE TO PLAY**

#### Students:

Education is key to your future. Your job is to be in school – every hour of every day.

#### Parents:

Parents/guardians are legally responsible for making sure their children attend every day school is in session. Children are not allowed to miss school without a legal excuse.

### School:

- Provide a program/schedule that meets the student's educational needs
- Address barriers to the child's ability to attend and learn
- Maintain accurate attendance records and document communication with students and parents/guardians about attendance

**DID YOU KNOW?** In Minnesota, every child between the ages of 7 and 17 is required to attend school full time. It's the law.

### THE ONLY LEGAL REASONS TO MISS SCHOOL:

- Sickness
- Doctor appointments
- Religious holidays
- Extreme family emergencies

## Consequences for not following the law

*For children under age 12*, parents can be petitioned to court for educational neglect and ordered to:

- cooperate with Child Protection
- participate in parenting classes, counseling sessions, or other services designed to improve their children's school attendance
- pay fines

*For children aged 12-17*, parents and/or students can be petitioned to court for truancy and ordered to:

- be placed under the supervision of Ramsey County Human Services
- participate in programs and/or services deemed appropriate for the student's specific situation
- not be allowed to drive until they are 18
- pay fines

In extreme cases, children can be removed from their parents' home and placed in foster care, with other adult family members, or in a shelter or group home.
