RESOLUTION CANVASSING RETURNS
OF VOTES OF SCHOOL DISTRICT GENERAL ELECTION

BE IT RESOLVED by the School Board of Independent School District No. 623, Roseville Area Schools ("the District"), as follows:

1. It is hereby found, determined, and declared that the general election of the voters of the District held on November 3, 2015, was in all respects duly and legally called and held.

2. As specified in the attached Abstract and Return of Votes Cast, a total of 2,757 voters of the district voted at said general election on the election of three (3) school board members for four (4) year term vacancies on the board caused by the expiration of term on the first Monday in January next following the general election as follows:

Boguszewski	1,459
Murray	859

3. Anderson, Azer, and Boguszewski, having received the highest number of votes, are elected to four (4) year terms beginning the first Monday in January 2016.

4. The District Clerk is hereby authorized and directed to certify the results of the general election to the County Auditor of Ramsey County. The Clerk is further authorized to provide written notice of the results of the elections to the Commissioner of Education in a timely manner.
