	<p>The board of Independent School District No. 622 (North St. Paul-Maplewood-Oakdale) has proposed to revoke the school district's existing referendum revenue authorization of \$489.86 per pupil and to replace that authorization with a new authorization of \$1,389.86 per pupil. The proposed new referendum revenue authorization would increase each year by the rate of inflation and be applicable for ten years, beginning with taxes payable in 2016, unless otherwise revoked or reduced as provided by law.</p> <p>Shall the school district's existing referendum revenue authorization be revoked and the increase in the revenue proposed by the board of Independent School District No. 622 be approved?</p> <p style="text-align: center;"> <input type="radio"/> Yes  <input type="radio"/> No                 </p> <p style="text-align: center;"><b>BY VOTING "YES" ON THIS BALLOT QUESTION, YOU ARE VOTING FOR A PROPERTY TAX INCREASE</b></p>	<p>The school board of 622 (North St. Paul-Maplewood-Oakdale) has proposed a capital project levy authorization to fund technology in the amount of 3.665% times the net tax capacity of the school district. The proposed authorization will raise approximately \$3,000,000 for taxes payable in 2016, the first year to be levied, and would be authorized for ten years. The estimated total cost of the projects to be funded over that time period is approximately \$30,000,000.
