

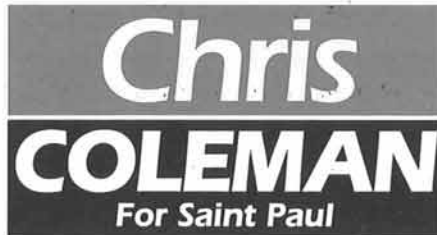

Enclosed please find the 2 week pre-election report for Chris Coleman for Saint Paul. The committee would also like to provide additional explanation regarding two contributions included on the 8 week pre-election report, which at the time of filing were still under review.

Following conversations with Ramsey County, Hennepin County and the Minnesota Campaign Finance Board, it is our understanding that the \$50 contribution from Mike Freeman for Hennepin County was acceptable. Therefore the contribution has not been refunded.

The \$500 contribution from Alfred Moore on 9/5/2013 has been partially allocated to his spouse Ann Moore, per Alfred's request. The contribution has been attributed \$250 to Alfred Moore (Retired) and \$250 to Ann Moore (Retired). A refund was not necessary following the re-allocation of funds.
