- 6. New Business:
  - A. Performance Measures and 2021 Supplemental Budget (3 Attachments) Presentation by County Manager Ryan O'Connor, Policy Director Elizabeth Tolzmann and Chief Financial Officer Alex Kotze: Ryan O'Connor shared the Supplemental Budget



and that priorities from last year's budget have not changed. Everything is rooted in Resident's First and how residents are experiencing our system. Elizabeth Tolzmann covered Performance Measures and details on indicators. She highlighted the plan to partner with community in order to reach goals. Last year, community visioning sessions were held to find out what indicators were important to residents. Alex Kotze added that flexibility and ability to pivot are important. There is a need to increase community engagement.

- B. Charter Commission Roles and Responsibilities County Attorney's Office (Attachment): Discussion was held on whether the Charter Commission has the authority to amend the Home Rule Charter. Yes, but it requires going to the voters during a general election. Member roles were highlighted including the role to periodically review the Charter to ensure it is up to date. Josh Ortiz clarified roles and referred to the attached documents got further discussion. Continued discussion and points shared from Sharon Garth reiterating member review of the Charter for changes, and John O'Phelan referred to the explicit overruling of general statutes. Amy Schmidt also shared the state statutes that apply to attorneys and the second chapter that applies to the Sheriff.
- C. Election of Chair and Vice Chair for 2021: Nominating Committee: Motion by Bill Kempe to appoint Nancy Haas as the 2021 Chair, seconded by Sharon Garth. Motion by Sue Majerus to appoint Angie Thies as the 2021 Vice Chair, seconded by Robert Humphrey. ROLL CALL was held all voted in favor.
- D. Approval of Dates for 2021 Meetings: February 1, 2021; May 3, 2021; August 2, 2021; and October 18, 2021.   - A. Charter Commission Overview and Duties: County Attorney Jim Mogen presents slides going over the general roles and responsibilities of the Charter Commission members. He gives a brief overview of the history and influence level.
  - B. Basics of the Open Meeting Law: County Attorney Jim Mogen presents slides going over the purpose of the Open Meeting Law and covers who it applies to and how it works. He

## Ramsey County Charter Commission and its Members

- Support "good government", the overarching intent of the Home Rule Charter, to "...make
  county government more visible and responsive to the residents of the county and to provide
  ways to make county government more flexible and efficient in addressing the needs of county
  residents."
- Have an interest in learning about and discussion of Ramsey County
- Recognize the roles of elected officials vs those of Charter Commission Members
  - o Charter Commission Members are appointed by the District Court
  - o County Commissioners, Attorney, and Sheriff are elected by the citizens
  - the Charter provides the mechanisms for elected County Commissioners to make the policy decisions
  - the Charter provides the mechanisms for professional staff to design, develop, and deliver services for the citizens of the County
- Periodically review the Charter
- Propose any necessary amendments to the Home Rule Charter
- Oversee the amendment process including
  - Review of any proposed amendments
  - Declare the sufficiency of a petition
  - Prepare a summary of any proposed amendment
  - Recommend any necessary revisions to proposed amendments
  - Submit proposed amendments to an election
- Attend all meetings of the Ramsey County Charter Commission
- Prepare for meetings by reading supplied documents prior to the meeting
