County Transportation System Overview

- 293 centerline miles
 - 842 lane miles
- Average Daily Traffic (ADT): 100 to 34,000+ vehicles per day (vpd)
 - Average ADT 9,500 vpd
- 57 bridges
- 297 miles of sidewalks / trails along county roads
- 21 miles of bicycle lanes on county roads

- Over 30,000 signs
- 365 signal systems
- Over 9,000 drainage structures/systems
- 4 Transitways
 - Green Line
 - Gold Line
 - Rush Line
 - Riverview

Pavement Preservation

- 12 separate locations
- 14.5 miles of bituminous road resurfaced
- 4.5 miles of concrete roads rehabbed
- 4 roads striped with bike lanes
 - Larpenteur Ave.- Hazel St. to McKnight Rd.
 - Payne Ave.- 7th St. to Edgerton St.
 - Edgerton St.- Little Canada Rd. to CR H2
 - Long Lake Rd.- Rice Creek to CR H2
- 13 accessible signals
 - Silver Lake Rd- CR E, Windsor Ln., 3rd St., 5th St., 7th St.
 - County Road C- CSAH 88, Walnut St., Long Lake Rd., Fairview Ave., Lincoln Dr.
 - Larpenteur Ave.- Cleveland Ave., Gortner St.
- 133 pedestrian ramps




Systemwide Safety Contributors








Contracting and Workforce Inclusion
