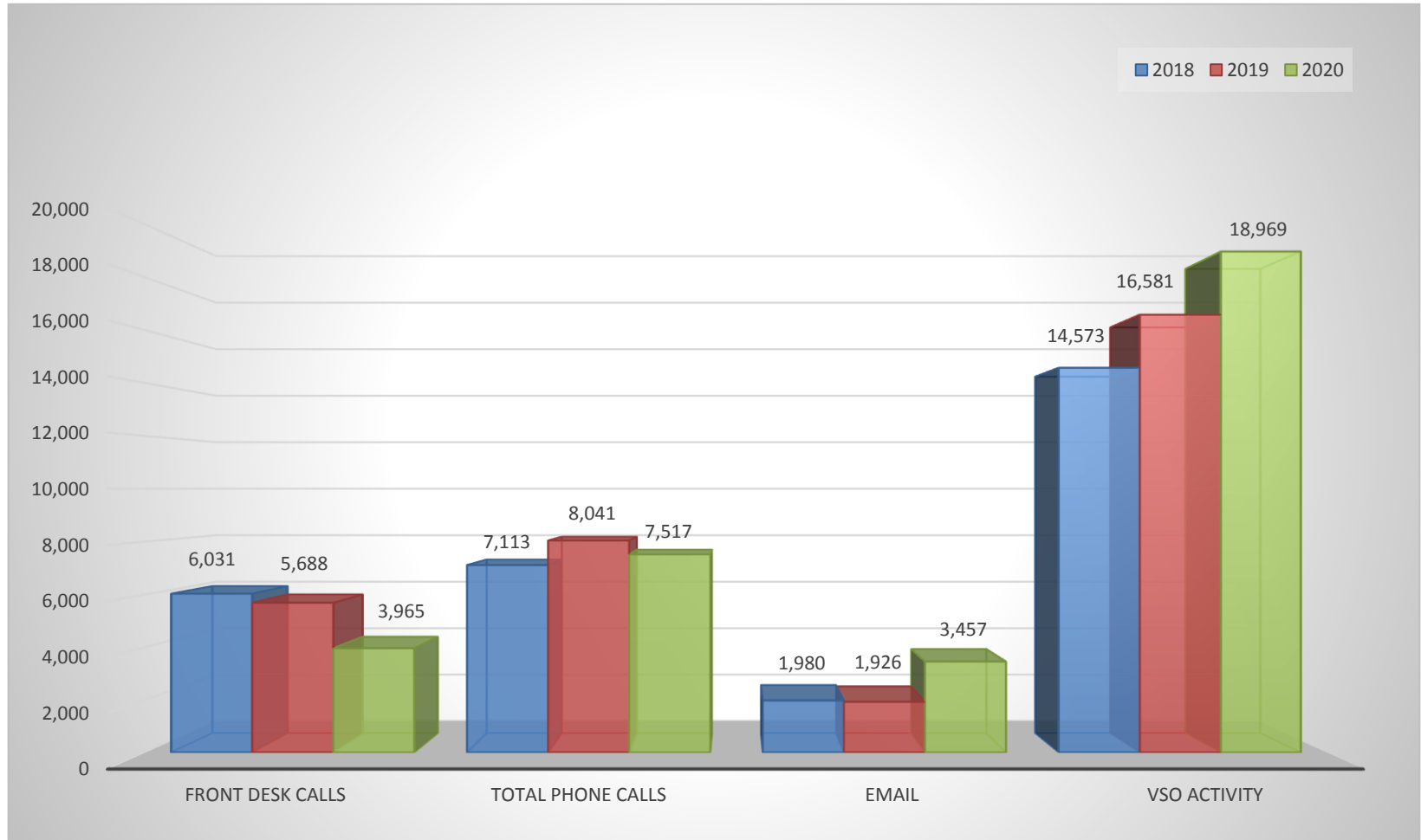

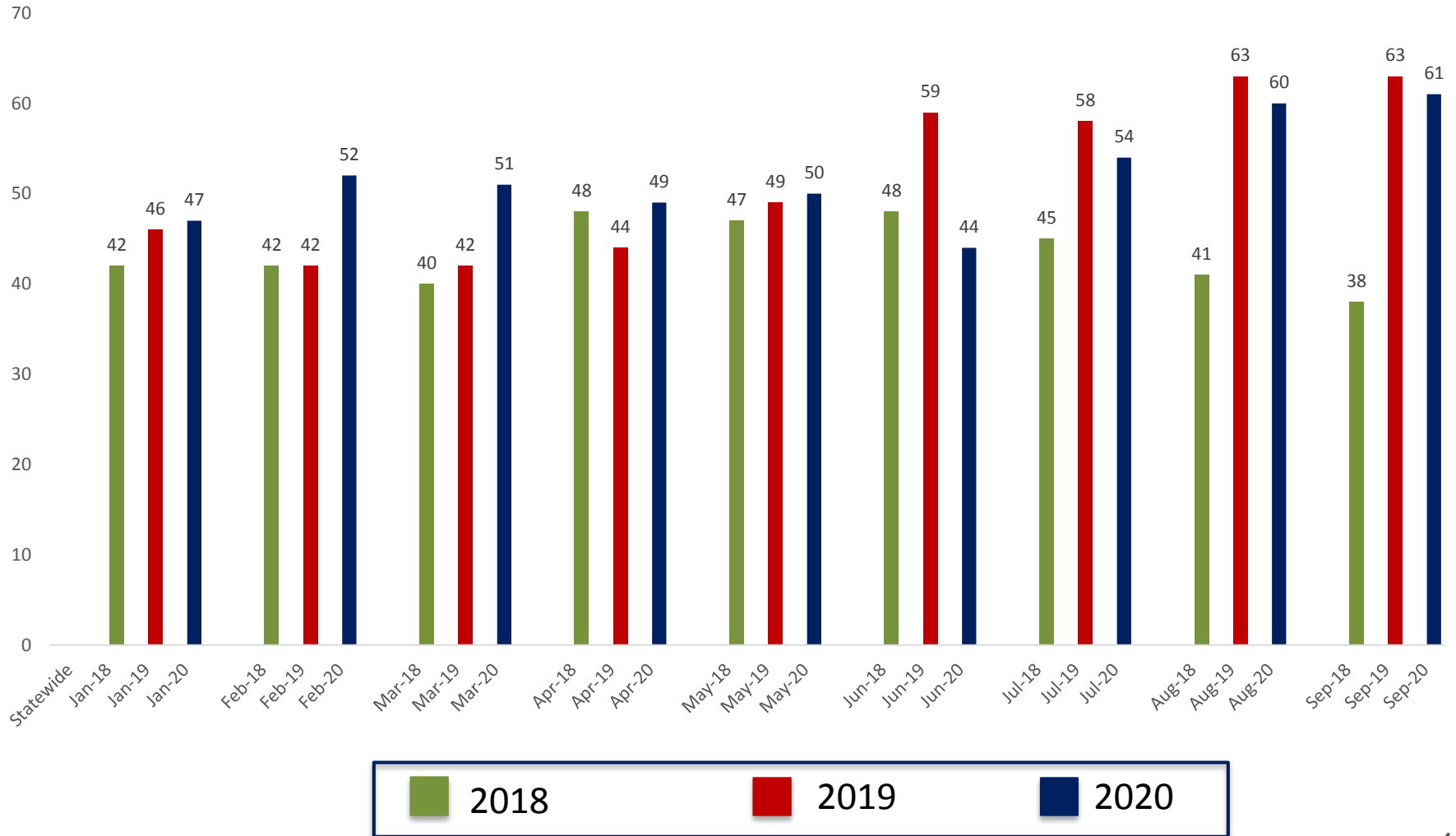

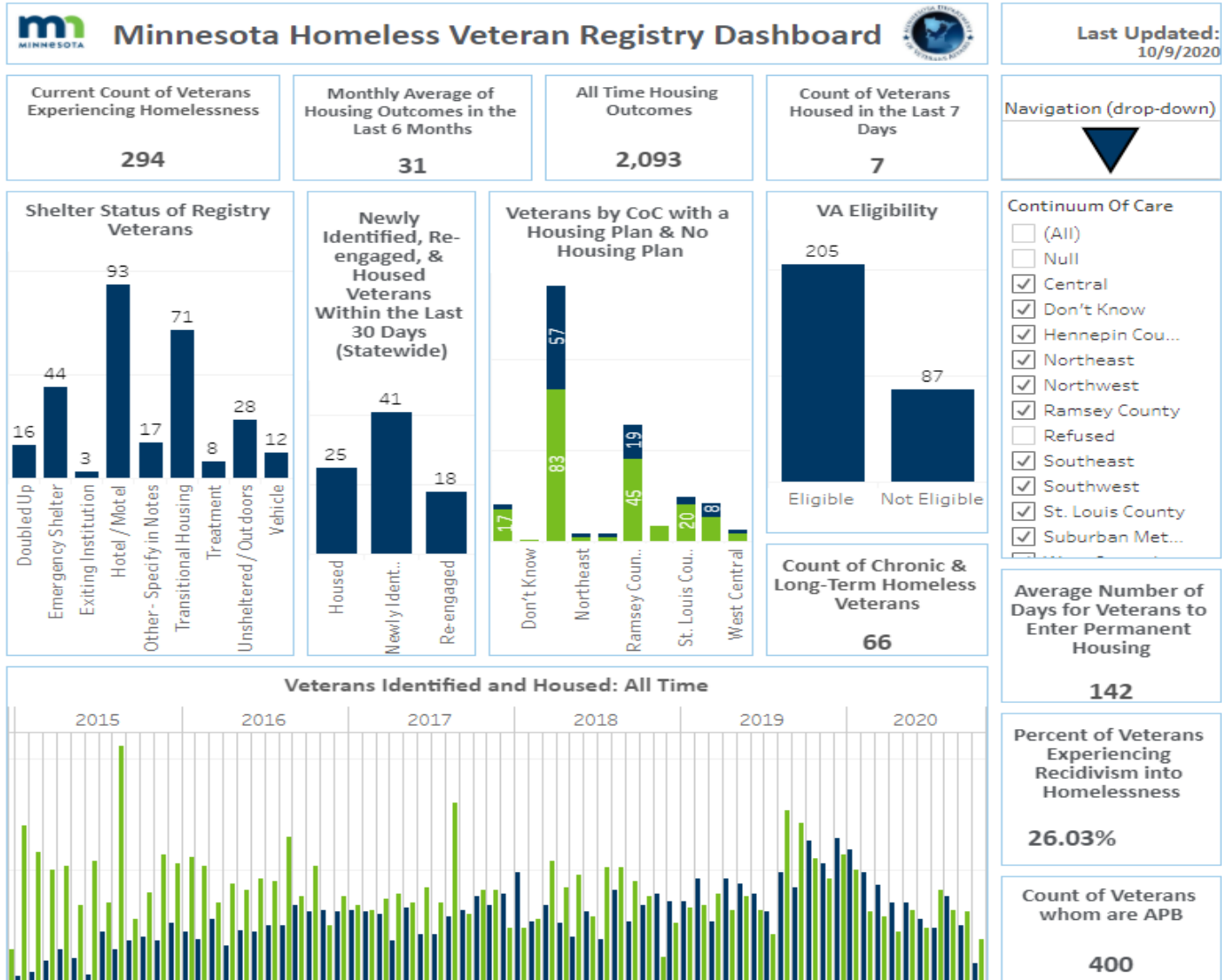

## The History

What is a Rule 20?

- Legal process
- Incompetent to stand trial

What is the current concern?

- Current criteria
- Department of Human Services (DHS) changes
- Fully understanding racial and ethnic impacts
- Treatment limitations and barriers

## Ramsey County's Response

What have we done so far?

- Formed a multidisciplinary county-wide team
- Researched, reviewed, educated and explored
- Hired a project manager
- Awarded DHS Innovations Grant
- Held two town hall events in partnership with National Alliance on Mental Illness (NAMI)
- Focus sessions with people who have been impacted by Rule 20

## Considerations

- DHS - Direct care and treatment changes
- Resident impact
- Impact on current resources
- Competency restoration taskforce
- Partnerships
