The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault - 4th Degree - Peace Officer - Demonstrable bodily harm

Minnesota Statute: 609.2231.1(c)(1), with reference to: 609.2231.1(c)

Maximum Sentence: 3 years or \$6,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 09/24/2021

Control #(ICR#): 21200036

Charge Description: On or about September 24, 2021, in the County of Ramsey, Minnesota, Cuyler Mason Howard did physically assault and inflict demonstrable bodily harm upon a peace officer licensed under state law who was effecting a lawful arrest or executing any other duty imposed by law.

COUNT II

Charge: Disarming a Peace Officer - Take Defensive Device from Peace Officer/Area Controlled by Officer

Minnesota Statute: 609.504.2

Maximum Sentence: 2.5 years or \$5,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 09/24/2021

Charge Description: On or about September 24, 2021, in the County of Ramsey, Minnesota, Cuyler Mason Howard did intentionally attempt to take possession of a defensive device being carried or employed by a peace officer or taken from an area within the officer's immediate control, without consent, while the officer was engaged in the performance of official duties.

COUNT III

Charge: Assault-5th Degree-Fear of Bodily Harm or Death

Minnesota Statute: 609.224.1(1)

Maximum Sentence: 90 days or \$1,000 fine, or both

Offense Level: Misdemeanor

Charge Description: On or about September 24, 2021, in the County of Ramsey, Minnesota, Cuyler

Mason Howard assaulted another and inflicted demonstrable bodily harm.

STATEMENT OF PROBABLE CAUSE

On September 24, 2021, at around 12:30 a.m., St. Paul police were dispatched to the 700 block of Linwood Ave. in the City of St. Paul, Ramsey County, on a report from two homeowners that someone was attempting to gain entry into their homes. One of the homes was on Linwood and the other a very short distance away on Grotto. Callers described the suspect as a white male in his 20s, about 6' tall, medium build, carrying a backpack and walking a dog.

A responding officer spotted a male fitting the description walking in the area of Osceola and Avon, about a block away from where the calls originated. The officer stopped his car, got out and asked the suspect, later identified as CUYLER MASON HOWARD (12/11/2000), to stop and put his hands on his head. The officer asked him to do so a second time. When HOWARD began to comply and the officer attempted to secure him, HOWARD punched the officer in the face with a close fist. The officer later said that he was stunned by the punch. HOWARD then proceeded to punch the officer in the head multiple times. The officer's face and uniform was splattered with the officer's blood.

The officer eventually was able to put HOWARD to the ground, whereupon HOWARD gauged at the officer's eyes and continued to punch the officer in the head. As the officer attempted to protect his eyes by burying his face in HOWARD's chest, HOWARD bit the top of the officer's head, leaving teeth marks on the officer's scalp. The officer described absorbing multiple blows to his head from HOWARD.

The officer was finally able to spray HOWARD in the face with ASR. As other officers arrived, HOWARD had his hand on the officer's holster in an apparent attempt to disarm the officer. Other officer's helped to secure HOWARD. Medics arrived. Mutliple photos were taken of the officer, who exhibited lacerations, a bite mark and blood on his face and uniform.

HOWARD repeatedly apologized and said he should not have fought the officer.

In a post-Miranda interview, HOWARD claimed that the officer surprised him and that he thought the officer was going to kill him. HOWARD stated that after the officer sprayed him in the face he tried to grab the officer's gun because he was so mad and that he wanted to kill the officer. "I thought he was going to kill me so I tried to kill him but then his gun was locked to his waist so I couldn't get his gun ... couldn't kill him." HOWARD stated that if he had had his own weapon that he would have just shot the officer and killed him. HOWARD acknowledged that he was at the two homes but claimed that he had just been looking around because he is interested in the homes in the area.

NOTICE: Pursuant to Minnesota Statute 609.49, subd. 1 (a) A person charged with or convicted of a felony and released from custody, with or without bail or recognizance, who intentionally fails to appear when required after having been notified that a failure to appear for a court appearance is a criminal offense, or after having been released on an order or condition that the release personally appear when required with respect to the charge or conviction, is guilty of a crime for failure to appear and may be sentenced to not more than one-half of the maximum term of imprisonment or fine, or both, provided for the underlying crime for which the person failed to appear, but this maximum sentence shall, in no case, be less than a term of imprisonment of one year and one day or a fine of \$1,500, or both.
