

• Establish a charter that guides how the group will function

- Review and refine project scope and timeline
- Develop public/stakeholder participation
- Determine the best and highest use of Ramsey County-owned facilities



- Recommend implementation plan for the long term strategy
- Recommend capital funding plan
- Review and analyze data –ongoing
- Review current contracting practices and make any necessary recommendations
- Review user fees, cost recovery, cost sharing, partnerships and fund-raising.
- Review non-county owned facilities and potential impacts on the arena market



- Provide periodic progress reports engaging public input
- Make the final presentation and recommendations to the County Board
- Work within the parameters as set forth by the County Board

# Timeline

- March Request Board action to appoint Ice Arena Task Force
- April Organization, orientation, background
- May Facility tours, historical background and data gathering
- June Technical analysis, subject matter expert interviews
- July Technical analysis, subject matter expert interviews, explore options
- August Begin prioritization, draft proposals/options/scenarios/concepts
- September Bounce ideas through community engagement
- October Community engagement, refine ideas
- November Develop and finalize recommendations, present draft to Board
- December Revise draft from Board reaction
- January Recommendations presented to County Board
