Topic: Pete Boulay from the State Climatology Weather: Past, Present and Future.

- In Summary:
 - The 2010's were an extraordinary wet period.
 - Dryness began in 2020, picked up speed in 2021 and eased in late 2021. A new drought arrived in 2022, but in 2023 the drought returned again.
 - After three winters of La Niña, a fairly strong El Niño is expected for the winter of 23-24.
 - The future trend is for a warmer and wetter climate, but expect variability.

Commission Chair Update: Greg Williams

- Greg asked how many people in the room know how to ride a bike and since it looks like all present do know how, Fat tire biking is a perfect winter activity for Ramsey County Parks & Recreation.
 - Greg reviewed the particulars of last February's Fat Bike Advocacy Days at Keller and Battle Creek Regional Park.
 - In partnership with staff (Mike Goodnature and Benjamin Karp) a new Fat Bike Trail is being proposed for Keller Regional Park. Greg shared a tentative project timeline, trail maps, wayfinding, sustainability and partnerships with local business and non-profits.
 - Mike commented that as long as people stay off the trails when it is wet or soft there is minimal to no impact to the area.
 - There is nothing like this in the East Metro area since MORC (Minnesota Off Road Cycling) is really concentrated to the West metro.
- On another note, the boat tour to Pig's Eye Island Building was off the hook and look forward to visiting the site again.
- Enjoyed working with everyone this year and look forward to 2024.

Director Update:

- Parks Summer rental season is done, golf courses shut down and moving into Ice and Cross-country ski season. The Battle Creek Winter Recreation Area is also getting ready to open. Since it's a bonding year the

2024 Legislative session will begin in February and Parks is putting forward requests with other metropolitan implementing agencies for infrastructure improvements. Mark wished everyone a Happy Holiday.
