#### **UPDATE FROM RAMSEY COUNTY**

- 1. Partner with **school and youth food programs** to expand and enhance existing services.
  - \$4.7 million dedicated
  - 4 new fully executed contracts, 3 in negotiations
  - USDA extended free meals through end of June 2021
- 2. Ensure that residents have access to **prepared meals, groceries, and basic needs** through partnerships with community providers.

Food program support:


- \$1.7 million dedicated to food shelf/groceries
- 20 executed or contract in negotiation

Home Delivered Meals:

- 8 contracts executed or in negotiations
- Estimated 130,000 meals delivered since August to those confined to their homes

- Child Protection workers deliver food to families & children
- Drive thru delivery fresh foods/dairy

- County plans for winter distribution
- Communication plan needs monitoring & enhanced
- Not everyone has access to internet

- Small community groups need connection with Ramsey Co for hot meal delivery
- Language line open to everyone
- Strategies for use of funds
- Contact with underserved to facilitate relationships

## What will mark success or failure?


- Vote


