



Notable Crimes Report

11/27/2020 – 12/4/2020

The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.

Gunfire Between Vehicles

Date and Time: November 20, 2020 at 7:31 pm
Location: Arlington Avenue West and Rice Street, Saint Paul

Police responded to a 9-1-1 call for gunshots in the area. Witnesses reported hearing approximately 20 shots being fired between two vehicles. One of the vehicles fled was followed by the second vehicle. The second vehicle continued shooting at the first vehicle. Several bullet casings were recovered from the scene. No injuries were reported.

Stabbing at Light Rail Station

Date and Time: November 20, 2020 at 11:09 pm
Location: 4th Street East Light Rail Station, Saint Paul

Two juvenile males were approached by an adult male and an adult female at the light rail platform. The two adults began harassing the juveniles. The adult male then pulled a knife out and stabbed one of the juveniles. The male suspect fled the scene. Police arrived to find the juvenile victims and the female suspect. Police spotted the male suspect near the Amtrak line; however, he fled and was not located. Police were able to identify the male suspect. The suspect was later arrested and taken into custody.

Fight in the Parking Lot of a Bar

Date and Time: November 21, 2020 at 1:03 am
Location: 2000 block of Rice Street, Little Canada

Deputies responded to a weapons complaint in the parking lot of a bar. Two groups had a dispute inside the bar which spilled out into the parking lot. One male had pulled up his shirt to reveal the butt of a pistol in his waistband. A second male was holding a rifle. Upon further investigation, a second rifle was located in the first male's vehicle. They both were arrested for 2nd Degree Assault and Terroristic Threats.

Drive-by Shooting

Date and Time: November 22, 2020 at 5:26 pm
Location: 600 block of Virginia Street, Saint Paul

Police responded to a 9-1-1 call for gunshots in the area. Neighbors reported that there have been many gunshots in the area recently. In this instance, surveillance video partially captured the shooting. A dark SUV was seen stopping at Thomas and Virginia where the occupants fired two shots. The SUV then flees the scene. Several bullet casings were recovered. No reports of injuries.

Patio Door Shattered by Gunfire

Date and Time: November 22, 2020 at 6:51 pm
Location: 1600 block of Conway Street, Saint Paul

A resident reported hearing her glass patio doors breaking. When she went to check her patio door, she noticed a bullet hole in the patio door. She never heard any gunshots. Officers located two bullet casings. No injuries were reported.

Person Held at Gunpoint

Date and Time: November 22, 2020 at 10:12 pm

Location: 600 block of Hawthorne Avenue East, Saint Paul

A witness reported seeing a male crying in the area. A pizza delivery person approached the crying male and asked if he needed any help. The crying male pulled a gun on the pizza delivery person and the delivery person fled the scene. The crying male then got into his own vehicle and fled the scene.

Dog Shot with a BB Gun

Date and Time: November 23, 2020 at 5:11 pm

Location: 2000 block of California Avenue East, Saint Paul

A 9-1-1 caller reported letting her dog out in her yard. When she went to retrieve her dog, it ran back inside the house with numerous injuries. She reported seeing a blue SUV driving slowly past her house. She believes the occupant(s) shot her dog with a bb gun.

Robbery at Gunpoint

Date and Time: November 23, 2020 at 9:42 pm

Location: BP Gas Station on Snelling Avenue North, Falcon Heights

Deputies took a robbery report from a victim that stated that he had arranged to purchase a PS4 gaming console on a marketplace app. When the suspect arrived, he attempted to enter the victim's vehicle. The victim had his doors locked. The suspect pointed a handgun at the victim and robbed him of his cash and wallet. The suspect fled the scene.

Breaking Into a Vehicle

Date and Time: November 23, 2020 at 11:31 pm

Location: 1000 block of English Street, Saint Paul

Two suspects were attempting to break into a resident's car. The two suspects were confronted by the resident and neighbors. One of the suspects threatened to shoot one of the neighbors. The two suspects then attempted to flee the scene. Neighbors were able to apprehend one of the suspects until police arrived. The suspect who had threatened to shoot the neighbor was not located.

Male Left at Hospital with Gunshot Wound

Date and Time: November 24, 2020 at 3:47 pm

Location: Local hospital, Saint Paul

A juvenile male who was suffering a gunshot wound was dropped off at a local hospital by a silver sedan. The sedan quickly left the hospital. The juvenile stated he was shot while walking home. He refused to cooperate and initially provided a false name. He was later identified and found to have a felony warrant and two gross misdemeanor warrants.

Gunfire Into the Air

Date and Time: November 25, 2020 at 12:58 am

Location: 600 block of Cook Ave East, Saint Paul

Multiple 9-1-1 callers reported that two vehicles pulled up to a residence and fired shots into the air. Police responded to the scene and spoke with the residents. The residents stated that there was a fight at the residence prior to the shooting. Spent bullet casings and an unfired bullet were located at the scene.
