

# **Notable Crimes Report**

The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.

Homicide

**Date and Time:** December 25, 2020 at 9:21 pm **Location:** Turned self in at Ramsey County jail

A male suspect wanted in the death of a two-year-old gunshot victim turned himself in at the Ramsey County Jail on Christmas day. The two-year-old victim was the 34th homicide in Saint Paul this year. The suspect said he left a gun unattended. The suspect is charged with manslaughter and illegal possession of a firearm.

#### **False Imprisonment**

Date and Time: December 26, 2020 at 5:48 pm

**Location:** 1800 block of 7<sup>th</sup> Street East, Saint Paul

Police responded to a 9-1-1 call for false imprisonment and violation of a protection order. Upon arriving at the apartment police found a locked and barricaded door. The male suspect said he would not let the female victim go and threatened to set fire to the apartment. Police entered the apartment where they encountered smoke, safely evacuated the victim, and arrested the suspect.

## Robbery & Sexual Assault

**Date and Time:** December 27, 2020 at 5:14 pm 1000 block of Sims Avenue, Saint Paul

Police responded to a 9-1-1 call for a robbery in progress. A concerned citizen called 9-1-1 reporting three males approached a male victim and then forced him into a house. The male victim was robbed at gunpoint. A female victim who was also in the house was sexually assaulted by one of the male suspects. All three suspects had firearms. Two of the three suspects were arrested at the scene. The third suspect has not been located. The suspects were arrested for aggravated robbery, criminal sexual conduct, false imprisonment, and possession of a firearm by an ineligible.

#### **Auto Theft**

Date and Time: December 28, 2020 at 5:39 pm

**Location:** 1700 block of Reaney Avenue, Saint Paul

Police responded to a 9-1-1 call for a stolen vehicle. The suspect took the victim's vehicle as the victim was delivering a pizza. The victim reported that he had a firearm in the glove compartment of the vehicle. The vehicle was involved in a crash a short time later. The suspects fled the scene. The vehicle and firearm were both recovered.

Robbery

Date and Time: December 28, 2020 at 5:47 pm

**Location:** 300 block of Cesar Chavez Street, Saint Paul

Police responded to a 9-1-1 call for an aggravated robbery. A female victim was exiting her vehicle when two male suspects assaulted her. The suspects robbed her at gunpoint and took her purse.

**Motor Vehicle Theft** 

Date and Time: December 28, 2020 at 11:38 pm

**Location:** Mounds View Boulevard and Edgewood Drive, Mounds View

Police observed a vehicle that had a headlight out and was missing a front license plate. The vehicle was stolen during an armed robbery. A traffic stop was conducted. There were three males and one female in the vehicle. The male driver was taken into custody for receiving a stolen vehicle and second degree DWI.

Kidnapping

Date and Time: December 29, 2020 at 3:19 pm

**Location:** Rice Street and County Road C, Little Canada

Deputies responded to a 9-1-1 call for a possible kidnapping. The caller, the victim's roommate, shared that the female victim was with the male suspect in a vehicle. Deputies located the vehicle and apprehended the suspect. The victim had been assaulted and held against her will over the course of several days.

**Domestic Assault** 

Date and Time: December 30, 2020 at 9:01 am

**Location:** 2600 block of Rice Street, Little Canada

Deputies responded to a 9-1-1 call for a hit and run vehicle accident. The female victim told deputies that the person who hit her was her boyfriend and that he intentionally rammed her vehicle. The victim told deputies that she was trying to escape the abusive relationship The description of the suspect's vehicle was shared with law enforcement in the area. The suspect was located a short time later and taken into custody.

**Shooting** 

**Date and Time:** December 30, 2020 at 7:23 pm 00 block of Atwater Street, Saint Paul

Police responded to a 9-1-1 call for a male suspect that was outside a residence with a gun. When police arrived the victim told police that the suspect had entered the residence and assaulted them. The victim also stated that when the suspect left the residence he fired a handgun and struck the residence with gunfire.
