

Notable Crimes Report

1/1/2021 - 1/8/2021

The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.

Aggravated Assault

Date and Time: January 1, 2021 at 8:41 pm

Location: 1500 block of Magnolia Avenue East, Saint Paul

Police responded to a 9-1-1 call for an aggravated assault, which involved the display of a firearm. Police learned there was an altercation between two females and a male. During the altercation the male suspect allegedly pointed a handgun at one of the females. The male suspect was arrested for aggravated assault. He also had a warrant for a parole violation.

Vehicle Pursuit

Date and Time: January 4, 2021 at 3:05 am

Location: Beam Avenue and Southlawn Drive, Maplewood

Deputies located a vehicle that had fled from Maplewood Police. Deputies engaged in a pursuit that started at Highway 36 and English Street in Maplewood and ended in Brooklyn Center. The pursuit covered 35 miles and lasted 28 minutes. The male suspect was booked for fleeing police in a motor vehicle, procession of narcotics, and a warrant for a parole violation.

Reckless Discharge of a Firearm

Date and Time: January 4, 2021 at 3:50 pm

Location: Rice Street and Sherburne Avenue, Saint Paul

Police were on patrol when officers observed a male near a parked vehicle and then heard a gunshot. The male was reaching under the vehicle for a firearm he had hidden when it discharged. Police recovered the firearm and took the male into custody.

Shooting

Date and Time: January 4, 2021 at 8:52 pm

Location: Hoyt Avenue West and Albemarle Street, Saint Paul

Police responded to a 9-1-1 call for shots fired in the area. Police located the shooting victim on the 1300 block of Arkwright Street. The victim had a non-life-threatening gunshot wound to the arm. The victim's friend had taken the victim away from the scene of the shooting. Police also located a stolen vehicle with bullet holes in it in a nearby parking lot. The victim told police that the shooting took place on the 1400 block of Rice Street and described the male suspect as wearing a facemask and fleeing in an SUV.

Attempted Carjacking

Date and Time: January 5, 2021 at 3:41 am

Location: 1700 block of Old Hudson Road, Saint Paul

Police located a stolen vehicle in a parking lot in the 1700 block of Old Hudson Rd. The stolen vehicle had been involved in attempted carjacking in Oakdale. The driver and a passenger were taken into custody and transported to the Juvenile Detention Center.

Firearm and Narcotics

Date and Time: January 5, 2021 at 6:36 pm

Location: Mackubin Street and Minnehaha Avenue, Saint Paul

While conducting a traffic stop, police detected the smell of marijuana. Police recovered a handgun under the seat of the male driver as well as narcotics. The male driver was taken into custody.

Vehicle Pursuit

Date and Time: January 6, 2021 at 2:16 am

Location: Snelling Avenue and Hoyt Avenue, Saint Paul

Deputies performed a traffic stop on a vehicle for having no license plates or a temporary tag. As the deputy approached, the vehicle fled at a high rate of speed. A pursuit was started, the pursuit lasted three minutes before deputies were able to safely disable the vehicle. A male suspect was arrested and booked for fleeing police in a motor vehicle. He also had two warrants out for his arrest.

Attempted Burglary and Fleeing Police

Date and Time: January 7, 2021 at 12:46 am

Location: 2600 block of Rice Street, Little Canada

While on patrol a deputy stopped to check on a vehicle behind a closed business on the 2600 block of Rice Street. The vehicle immediately began to flee at a high rate of speed. A pursuit lasted less than one mile and then was terminated when the suspect vehicle began driving north in the southbound lanes of I35E from Little Canada Road. An attempted burglary report was taken from the business after pry marks were found on the back door and a broken window found in front. Two similar incidents occurred in the vicinity at around the same time, one with a matching vehicle description.

Fatal Collision Involving a Stolen Vehicle

Date and Time: January 7, 2021 at 3:06 am

Location: Minnehaha Avenue and Atlantic Street, Saint Paul

Police responded to a 9-1-1 call for an accident with injuries. Police discovered a stolen vehicle had crashed into another vehicle and the occupants of the stolen had fled on foot. One person in the victim's vehicle was pronounced dead at the scene and another was transported to a local hospital.
