The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.

Motor Vehicle Theft

Date and Time:January 8, 2021 at 4:51 amLocation:2800 block of Rice Street. Little

Location:2800 block of Rice Street, Little CanadaWhile on patrol, a deputy observed a running vehicle with no license plates in the parking lot of a
business. Two people were sleeping inside the vehicle. The vehicle was stolen out of Burnsville. The
driver and passenger were taken into custody. During the vehicle search, the deputy found

suspected methamphetamine, paraphernalia, checkbooks, and social security cards of other people.

Assault

Date and Time: January 8, 2021 at 5:21 pm

Location: 1900 block of University Avenue West, Saint Paul

Police responded to a 9-1-1 call for a male in the lobby of an apartment complex with a gun. The apartment complex's property management stated a male and a female were having a verbal dispute in the lobby. Property management attempted to intervene. The male went back to the female's apartment then returned to the lobby. The male implied that he had a gun. The male threatened to shoot property management and the female. Police arrested the male but did not locate a firearm.

Carjacking

Date and Time: January 9, 2021 at 7:26 pm

Location: 1000 block of Payne Avenue, Saint Paul

Police responded to a 9-1-1 call for a motor vehicle that was stolen at gunpoint. The suspect approached the victim who was sitting in a parked vehicle. The suspect pointed a handgun at the victim, then got into the vehicle and fled from the area.

Motor Vehicle Theft

Date and Time: January 10, 2021 at 5:20 pm

Location: Dale Street and Thomas Avenue, Saint Paul

While on patrol, police saw a stolen vehicle with out of state license plates. The vehicle had been stolen at gunpoint in a Minneapolis carjacking several days prior. Since the carjacking, the vehicle had been involved in an additional carjacking as well as fleeing from police on multiple occasions. Police followed the vehicle to a gas station. Police conducted a traffic stop. Five juvenile suspects were taken into custody and transported to the Juvenile Detention Center.

Fleeing Police

Date and Time:January 10, 2021 at 11:57 pmLocation:Sherburne Avenue and Grotto Street

As police were conducting a traffic stop on a vehicle, the vehicle accelerated and failed to stop. Police did not pursue. A short time later, police located the suspect vehicle and observed a male running on foot away from the vehicle. Police were able to apprehend a 40 year old male suspect. He was arrested for fleeing police in a motor vehicle, fleeing on foot, and predatory offender registration non-compliance. Police learned that the vehicle had been stolen at gunpoint in Minneapolis several days prior.

Burglary

Location: 100 block of Bigelow Lane, Saint Paul

A male victim stated he was leaving a friend's house on foot when two males approached him. The males demanded the victim's belongings. One suspect pointed a handgun at the victim. The victim's cellphone and wallet were taken.

Shooting

Date and Time: January 12, 2021 at 6:22 pm

Location: Prosperity Avenue and Hazelwood Avenue, Saint Paul

Police responded to a 9-1-1 call for a shooting at the intersection of Prosperity Avenue and Hazelwood Avenue in Saint Paul. Police located a male victim sitting in a vehicle with gunshot wounds. The male victim suffered a non-life threatening gunshot wound.

Theft of a Motor Vehicle and Fleeing Police

Date and Time: January 13, 2021 at 2:14 am

Location: Highway 61 and Interstate 694, Vadnais Heights

A deputy witnessed the crash of a stolen vehicle out of Woodbury. The juvenile male driver fled on foot into a wooded area on the northwest corner of Interstate 694 and Highway 61. Deputies, including a canine, tracked the suspect into the woods where the juvenile suspect was arrested for burglary, auto theft, and fleeing police on foot.
