

Notable Crimes Report

1/15/2021 - 1/22/2021

The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.

Possession of Burglary Tools and Identity Theft

Date and Time: January 15, 2021 at 3:30 pm

Location: Maryland Avenue East and Herbert Street East, Saint Paul

Police responded to a 9-1-1 call for an adult male looking in parked vehicles. The suspect was located and found to have a active arrest warrant. The suspect was also in possession of burglary tools and a number credit cards that did not belong to him.

Possession of Firearm by an Ineligible Person

Date and Time: January 15, 2021 at 5:24 pm

Location: Mounds Boulevard and Earl Street, Saint Paul

Police located a vehicle wanted by the Inver Grove Heights Police Department. A traffic stop was

conducted. The driver appeared intoxicated and police had the driver step out of

the vehicle. A gun was found on the driver's seat. The driver also had an active arrest warrant.

Robbery

Date and Time: January 15, 2021 at 9:45 pm

Location: 1800 block of Furness Street North, Maplewood

A female was robbed at gun point by two males. Both males had guns and were wearing dark clothing and masks. The suspects took the victim's phone and wallet. Both suspects fled the scene on foot. A police canine was used to track the suspects, but lost track of the suspects after a few blocks.

Possession of Firearm by an Ineligible Person

Date and Time: January 15, 2021 at 10:39 pm

Location: Charles Avenue and Lexington Parkway North, Saint Paul

Police conducted a traffic stop on a vehicle. A search found two loaded handguns, firearms with altered serial numbers, and spent bullet casings in the backseat. The driver and passenger were both ineligible to possess firearms or ammunitions. One of the occupants also had an active arrest warrant.

Robbery

Date and Time: January 16, 2021 at 2:54 am

Location: 2000 block of Dayton Avenue and 900 Block of Goodrich Avenue, Saint Paul

Four people were walking in the 2000 block of Dayton Avenue when they were followed by a male dressed in all black and wearing a mask. A vehicle following the male suspect pulled past the victims and stopped in front of the victims. Two males exited the vehicle with guns while the driver stayed in the car. The original suspect joined the two males. The three male suspects demanded the victims' valuables. The three males then got back into the car and fled the scene.

As officers were taking this report, a second robbery call came out. A female victim was carjacked on the 900 block of Goodrich Avenue. Three males exited a vehicle that matched the same description as the previous call. The males displayed handguns and demanded keys for the victim's vehicle. The suspect vehicle and the victim's vehicle then fled westbound.

Possession of Synthetic Narcotics

Date and Time: January 16, 2021 at 5:25 am

Location: York Avenue and Arcade Street, Saint Paul

Police conducted a traffic stop on a vehicle for equipment violations. Marijuana was in plain sight. A search of the vehicle also found synthetic narcotics. A spent bullet casing was located near the wipers of the front windshield. The male driver was arrested.

Gunfire Between Two Males

Date and Time: January 16, 2021 at 4:36 pm 400 block of Concord Street

Police responded to a 9-1-1 call for two males shooting at each other. One suspect was in a SUV and the second male was on foot. The SUV fled the scene. The male on foot entered a nearby residence. The male that entered the residence was located and arrested. The SUV was not located.

Motor Vehicle Theft

Date and Time: January 16, 2021 at 6:54 pm

Location: 1900 block of Twin Lakes Parkway, Roseville

A male approached a female victim and asked for help jumpstarting his vehicle. As the victim exited her vehicle, the male suspect entered her vehicle and drove off. State Patrol later recovered the vehicle in Minneapolis.

Shooting

Date and Time: January 16, 2021 at 7:06 pm

Location: 1000 block of Hudson Road, Saint Paul

Multiple 9-1-1 callers reported hearing 10 to12 gunshots fired near a bar. No suspect description was provided. Several spent bullet casings were located in the street. Shortly after, there was a report of a gunshot victim being dropped off at a local hospital. The victim had suffered a non-life-threatening gunshot wound. He refused to cooperate with police.

Assault

Date and Time: January 17, 2021 at 8:20 pm

Location: 1300 block of Park Street, Saint Paul

Police responded to a 9-1-1 call for a pregnant female who was shot. The female was transported to a local hospital with a non-life-threatening gunshot wound. The bullet missed the unborn child. A male from the apartment was arrested.

Reckless Discharge of a Firearm

Date and Time: January 18, 2021 at 2:35 pm

Location: 800 block of Wakefield Avenue, Saint Paul

Police responded to a 9-1-1 call for a person firing a gun into the air. Upon arriving police observed a male suspect walking in and out of his house several times. Each time he came outside he would discharge his firearm into the air. Several spent bullet casings were laying on the deck of the home. SWAT arrived and assisted with taking the suspect into custody.

Juveniles in Possession of a Firearm

Date and Time: January 19, 2021 at 12:05 am

Location: Kennard Street and Case Avenue, Saint Paul

Police conducted a traffic stop on a vehicle for driving with no headlights. The vehicle was occupied

by four juveniles. Officers located a firearm in the vehicle. All four juveniles were arrested.

Gunfire Between Two Males

Date and Time: January 19, 2021 at 8:08 pm

Location: Fourth Street East and Earl Street, Saint Paul

Multiple 9-1-1 callers reported that two people were shooting at each other. Upon arriving, police located a male suspect with a gunshot wound to the leg. The male was transported to a local hospital for treatment and then was taken into custody. The second suspect was not located.

Carjacking

Date and Time: January 20, 2021 at 5:00 am

Location: 900 block of West County Road D, New Brighton

A male was released from the Ramsey County Jail. A good samaritan agreed to give him a ride. The male suspect had the good samaritan drive him to the 600 block of Rice Street in Saint Paul where the suspect then stole the good samaritan's car. The suspect drove to New Brighton, where he was arrested for motor vehicle theft and returned to jail four hours after being released.
