

Notable Crimes Report

1/22/2021 - 1/29/2021

The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.

Hit and Run Homicide

Date and Time: January 22, 2021 at 8:37 pm

Location: McKnight Road North and Margaret Street, Saint Paul

A 68-year-old male was found lying against a snowbank on the road. Paramedics arrived and were unable to find a pulse on the male. The male appeared to have been struck by a vehicle. A male suspect has been arrested and charged with criminal vehicular homicide.

Criminal Damage to Property

Date and Time: January 22, 2021 at 10:15 pm

Location: 1400 block of Magnolia Avenue East, Saint Paul

Police responded to the area on reports of two males casing/looking into cars in the parking lots. Police located two males in the act of cutting a catalytic converter off a vehicle. The vehicle was damaged extensively. One of the males had a felony drug warrant. Both males were arrested.

Criminal Damage to Property

Date and Time: January 23, 2021 at 3:52 pm

Location: 20 block of Old County Road C, Little Canada

A resident noticed two males and a black SUV in his driveway. One of the male suspects was under the homeowner's SUV attempting to remove the catalytic converter. The second male suspect was standing next to the unknown black SUV. The resident approached the two male suspects and began yelling at them. The second male suspect then appeared to be pulling an item from his pocket. Fearing the item was a gun, the homeowner retreated into his garage. Both suspects got into the black SUV and fled the scene.

Robbery of a Blind Victim

Date and Time: January 23, 2021 at 6:58 pm

Location: Chatsworth Street South and James Avenue West, Saint Paul

A legally blind male, out for a walk, was approached from behind and shoved to the ground. Three male suspects kicked the victim while he was down and rifled through his pockets. The suspects demanded that the victim give them his wallet. When the three suspects could not find the victim's wallet, they fled the scene.

Accident with Property Damage

Date and Time: January 24, 2021 at 12:12 am

Location: Highway 61 and Larpenteur Avenue East, Maplewood

Police responded to a single vehicle rollover on US Highway 61. When police arrived, there were no occupants in the vehicle. Police found two set of tracks leading away from the vehicle. One male was located in a nearby backyard hiding inside a child's playhouse. It was unclear if the male was the driver or a passenger, but he did have injuries. The male was under the influence and had an active warrant for his arrest. The owner of the second set of tracks was not located.

Suspicious Vehicle

Date and Time: January 24, 2021 at 2:26 pm

Location: 1000 block of County Road D, Vadnais Heights

Deputies responded to a 9-1-1 call for a suspicious SUV that was driving through a parking lot slowly and appeared to be casing/looking at vehicles. The license plate on the SUV came back to a stolen vehicle out of Saint Paul. Deputies were able to stop the stolen SUV. Two males were arrested. Items inventoried from the SUV included a sledgehammer, window break hammer, replica Berretta airsoft handgun, and a mail with names not matching the suspects.

Robbery and Carjacking

Date and Time: January 25, 2021 at 8:41 pm

Location: 500 block of Portland Avenue, Saint Paul

A woman had just parked her vehicle in her driveway when she was approached by two males. The males both pointed handguns at her and demanded her belongings. The suspects stole the victim's wallet, cellphone, and vehicle.

Shooting Between Two Vehicles

Date and Time: January 25, 2021 at 8:46 pm

Location: 600 block of Virginia Street, Saint Paul

Multiple 9-1-1 callers reported hearing between six and twenty gunshots fired in the area. Police

arrived and located two vehicles involved in a shooting. One male was arrested.

Catalytic Converter Theft

Date and Time: January 25, 2021 at 10:46 pm

Location: 2000 block of Lexington Avenue, Roseville

A 9-1-1 caller reported seeing a black SUV and hearing a saw. The caller believed the occupants of

the vehicle were stealing catalytic converters. Police arrested a male and two females.

Stabbing

Date and Time: January 26, 2021 at 11:01 pm

Location: Seventh Street East and Temperance Avenue, Saint Paul

Police responded to a 9-1-1 call for a stabbing. The victim was approached by a male suspect. The suspect wanted the victim's belongings. When the victim tried to fight the suspect off, the suspect

stabbed the victim. The suspect fled the scene on foot and was not located.

Stabbing

Date and Time: January 26, 2021 at 11:09 pm

Location: 2500 block of White Bear Avenue North, Maplewood

Police responded to a 9-1-1 call for a stabbing. Police arrived at the business where the call was placed and found a male bleeding from his head and hands. The victim stated the suspect was in a homeless encampment behind the business. Police located the suspect and arrested him. Both males were staying in tents in the woods when the suspect assaulted the victim with a knife.

Shooting

Date and Time: January 27,2021 at 12:02 pm

Location: 1400 block of York Avenue, Saint Paul

Multiple 9-1-1 callers reported hearing several gunshots fired in the area. One caller stated he was shot. Upon arriving police discovered two juveniles with gunshot injuries. The two juveniles were transported to a local hospital for medical treatment. A short time later another juvenile arrived at the hospital with gunshot wounds. It was determined that the juvenile was also involved in the incident.
