



Notable Crimes Report

1/29/2021 – 02/5/2021

The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.

Robbery

Date and Time: January 28 at 3:51 pm
Location: 1100 block of Arcade Street, Saint Paul

Two to three teenage males approached a female while she was walking to her car. The suspects ripped the victim's purse from her and took her car keys. The suspects then fled in a van. The female victim ran into a nearby local business to call 9-1-1. When she returned outside, her vehicle was missing.

Motor Vehicle Theft

Date and Time: January 28, 2021 at 5:36 pm
Location: Orange Avenue East and Flandrau Street, Saint Paul

Two males attempted to steal a running vehicle that was parked in a driveway. The suspects got into the vehicle and drove it down the street. The suspects attempted a U-turn and then got stuck in a snowbank. Witnesses saw the suspects exit the stolen vehicle and climb into a van. The van was spotted by police. The van failed to stop for police; police did not pursue. The license plate on the van came back as a stolen vehicle.

Robbery

Date and Time: January 28, 2021 at 5:45 pm
Location: 500 block of Lincoln Avenue, Saint Paul

A female was unpacking items from her vehicle when she was approached by a juvenile male. The male suspect pointed a handgun at the female victim and demanded the victim's car keys. The victim threw her car keys and fled inside her house. The suspect then took the victim's vehicle.

Hit and Run

Date and Time: January 28, 2021 at 5:57 pm
Location: Seventh Street East and Eichenwald Street, Saint Paul

A female was struck by a vehicle on Seventh Street. The victim was transported to a local hospital where she later died. The suspect vehicle left the scene immediately after striking the victim.

Shots Fired

Date and Time: January 30, 2021 at 3:52 am
Location: 1800 block of Gluek Lane, Roseville

Police responded to a 9-1-1 for a large group arguing and shots being fired near Gluek Lane and Fairview Avenue. Police arrived to upwards of 50 people in the street and multiple vehicles leaving the area. Several bullet shell casings were located in the street. The group was attending a party in the area. The party was dispersed without incident.

Triple Homicide

Date and Time: January 30, 2021 at 3:07 pm

Location: 700 block of Jessie Street, Saint Paul

Police responded to a 9-1-1 call for three people found in a house "with blood everywhere." Police located three victims each with multiple gunshot wounds. An adult female, 30 years old and a juvenile female, 12 years old were deceased. A juvenile male, 11 years old was breathing but unconscious, he was transported to a local hospital. The 11 year old victim was able to identify the male suspect before the victim died from their injuries. Police were able to gather surveillance video from the area and identify a suspect vehicle. The vehicle was later found abandoned on the side of the road. Police were able to confirm the identity of the suspect. The suspect was arrested and charged for the three homicides.

Stolen Vehicle

Date and Time: January 31, 2021 at 12:29 am

Location: 1200 block of White Bear Avenue, Saint Paul

While on patrol police located a stolen vehicle. The vehicle was stolen in an armed robbery out of North Saint Paul 10 minutes prior. Police attempted to conduct a traffic stop. The vehicle failed to stop and attempted to flee from police but crashed. The driver ran from the crashed vehicle but was apprehended after a short chase on foot. The driver had discarded a firearm while fleeing. Officers were able to recover the firearm.

Vehicle Pursuit

Date and Time: January 31, 2021 at 7:54 pm

Location: Interstate 35 East and Maryland Avenue, Saint Paul

Police attempted to conduct a traffic stop on a vehicle being driven by a male with multiple felony warrants. The vehicle failed to stop and fled from police. After a short pursuit police were able to disable the vehicle. Multiple people fled on foot from the vehicle. Police were able to apprehend two suspects, one of whom had multiple arrest warrants.

Robbery

Date and Time: February 1, 2021 at 4:50 pm

Location: 2000 block of Benson Avenue, Saint Paul

A husband and wife were robbed at gunpoint by two males. The two suspects fled in a car that was occupied by two other males.

Robbery

Date and Time: February 1, 2021 at 5:05 pm

Location: 600 block of Kenneth Street, Saint Paul

A female was approached by two males while in the front of her residence. One of the suspects pulled a handgun and demanded her car keys. The victim refused and began yelling for help. The two suspects then fled the scene in a car that was parked nearby. A surveillance camera in the area was able to capture the car on video.

Robbery

Date and Time: February 1, 2021 at 6:59 pm

Location: 700 block of Snelling Avenue

Multiple 9-1-1 callers reported a vehicle accident. The victim stated that he was at a gas pump at a gas station when two males approached him. The two males wanted the victim's vehicle. The victim accelerated out of the gas station and was followed by the suspects in a car. A gunshot was fired from the suspect vehicle. The victim then crashed their vehicle. Officers in the area noticed the suspect vehicle driving through stop signs. The suspect vehicle crashed and police were able to arrest one male. The second male was not located.

Motor Vehicle Theft

Date and Time: February 2, 2021 at 7:28 pm

Location: 1500 block of Randolph Avenue, Saint Paul

A female reported that her rental vehicle was stolen when she went into a local business. She had left the vehicle running with her therapy dog inside the car.
