

Notable Crimes Report

2/19/2021 - 2/26/2021

The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.

Motor Vehicle Theft

Date and Time: February 21, 2021 at 1:00 am

Location: Third Street East & White Bear Avenue North, Saint Paul

A female victim was pushed out of her vehicle by two male suspects who stole her car. The vehicle was the subject of a 9-1-1 call later that night reporting two unconscious people in the car. When squads arrived, the vehicle was unoccupied.

Attempted Motor Vehicle Theft

Date and Time: February 21, 2021 at 1:15 pm

Location: 2000 block of Maplewood Drive North, Maplewood

Police responded to a 9-1-1 call for an in-progress auto theft from a business. The suspect exited the vehicle when he saw the caller on the phone. The caller informed the officers of the suspect's direction of travel on foot and another witness guided them to an unlocked porch on a nearby building. The suspect, who has a lengthy criminal history, was taken into custody and booked for tampering with a motor vehicle.

Robbery

Date and Time: February 23, 2021 at 6:01 pm

Location: 400 block of Lexington Parkway North, Saint Paul

Police responded to a bank robbery at gunpoint. The suspect pointed a gun at bank employees and demanded money. The suspect fled on foot prior to police arriving and they were able to get away with \$2,000 in cash. Police setup a perimeter and conducted a search with assistance of a police canine. Police were unable to locate the suspect.

Carjacking at Gunpoint

Date and Time: February 23, 2021 at 6:11 pm **Location:** 694 & Rice Street, Shoreview

The victim's vehicle was rear ended by another vehicle. When the victim pulled over to the side of the road to inspect the damage, a male suspect got out of the other vehicle, walked towards the victim, pointed a handgun towards his chest, and said "Where are your keys? Behave or you'll get shot." The male suspect got into the driver's seat of the victim's vehicle and left the area. There were two other passengers in the suspect vehicle.

Homicide

Date and Time: February 23, 2021 at 8:03 pm

Location: 100 block of Hudson Road, Saint Paul

Police responded to a 9-1-1 call for a shooting. Upon arriving police located a man and a woman, each suffering from gunshot wounds. Both victims were transported to a local hospital. The male later died from his injuries. The woman is expected to survive.

Hit and Run

Date and Time: February 23,2021 at 9:29 pm

Location: 700 block of Thomas Avenue, Saint Paul

A 9-1-1 caller witnessed a van crash into a house. The vehicle got stuck between a tree and the porch. The suspect vehicle was able to get free and flee away from the scene. A female suspect was taken into custody.

Motor Vehicle Theft

Date and Time: February 23, 2021 at 10:52 pm

Location: Prosperity Avenue & Ames Avenue, Saint Paul

A stolen vehicle was located in the area of Prosperity Avenue & Ames Avenue Police arrived at the area and saw four juvenile suspects running from the stolen vehicle. Police set up a perimeter and had the stolen vehicle blocked in. Police witnessed three suspects running into the woods. Two juvenile suspects were taken into custody behind a house and a BB gun was located on the front porch. The other two juvenile suspects were taken into custody a short time later.

Shooting

Date and Time: February 23,2021 at 11:35 pm

Location: 800 block of Orange Avenue East, Saint Paul

Multiple 9-1-1 callers reported hearing several gunshots in the area. Upon arriving police located a male in the alley that said his friend has been shot and was inside the house. Police saw nine bullet casings and blood in the alley. Police located the victim inside the house who was suffering from a gunshot wound to the back. The victim was transported to a local hospital. Witnesses stated the suspects were driving an SUV.

Shooting

Date and Time: February 24, 2021 at 11:30 pm

Location: Case Avenue and Westminster Street, Saint Paul

Multiple 9-1-1 callers reported hearing shots fired in the area. Police arrived to find multiple bullet

casings and an unoccupied vehicle with a window shot out.
