



# Notable Crimes Report

4/16/2021 – 4/23/2021

*The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.*

## Aggravated Domestic Assault/Shooting/Attempted Murder

**Date and Time:** April 18, 2021 at 5:25 pm

**Location:** 300 Block of Ravoux Street, Saint Paul

Officers were sent to the 300 block of Ravoux Street on a report of a person being shot. Police located a female victim who sustained a gunshot wound to her leg. Officers located spent shell casings at the scene. The suspect fled on foot prior to officer's arrival and was identified as the victim's boyfriend. Officers learned the suspect made suicidal comments about killing himself and possibly committing 'suicide by police.' Three days later, the suspect turned himself in and was charged with attempted murder.

## Armed Carjacking

**Date and Time:** April 19, 2021 at 7:36 pm

**Location:** 300 block of South Owasso Boulevard, Little Canada and  
1900 block of Rush Lake Trail, New Brighton

Deputy responded to a 9-1-1 call for a report of armed carjacking in Little Canada. Deputies learned that two male suspects approached to two victims in a vehicle asking for a ride. When the male suspects were declined, they pointed a handgun at the victims and told them to get out of the car. The suspects drove off in the victim's vehicle. The next day, New Brighton Police observed a vehicle driving erratically. Officers learned it was the vehicle that was stolen out of Little Canada. Officers followed the vehicle into the parking lot of an apartment complex. The juvenile suspects fled from the scene. Officers set up a perimeter and K9 tracked with no success. Then, the officers located the juvenile suspects across the street and Deputies took them into custody. A backpack was located containing a handgun.

## Traffic Stop

**Date and Time:** April 19, 2021 at 8:00 pm

**Location:** 7th Street & Atlantic Street, Saint Paul

Officers conducted a traffic stop on a vehicle for a moving violation. The driver was taken into custody for possession of controlled substance and the front passenger was arrested for three outstanding warrants.

## Pursuit

**Date and Time:** April 20, 2021 at 3:40 am

**Location:** Payne Avenue & Geranium Avenue East, Saint Paul

Deputies heard Saint Paul Police were in a pursuit of an armed carjacking suspect vehicle which entered the City of Roseville. The suspect driver was fleeing at a high rate of speed. Deputies set up perimeter and successfully deployed stop sticks, which brought the suspect vehicle to a stop. Deputies took two suspects into custody.

**Burglary**

**Date and Time:** April 20, 2021 at 4:30 am

**Location:** 400 Mystic Street, Saint Paul

Officers were dispatched to the 400 block of Mystic Street regarding an alarm call. Upon arrival, officers spoke with homeowners who stated their basement door was open. Officers searched the basement and located a suspect inside. The suspect was identified as 29-year-old male and was arrested for burglary. The homeowners did not know the suspect.

**Attempted Carjacking**

**Date and Time:** April 20, 2021 at 4:21 pm

**Location:** 500 block of Grand Avenue, Saint Paul

Officers responded to a 9-1-1 call for a report of attempted carjacking. The complainant stated that he saw an SUV approach a vehicle. A juvenile suspect got out the SUV and yelled, "Give me your keys!" at a woman by the vehicle. The woman pushed the juvenile suspect down and got into her vehicle and left. The suspect got back into the SUV and left.

**Aggravated Domestic Assault/Shooting**

**Date and Time:** April 21, 2021 at 6:00 pm

**Location:** 100 Block of Bigelow Lane, Saint Paul

Officers were sent to an address where a child reported their father fired gun shots at their mother. No injuries were reported. Officers arrived and spoke with the female victim, who told police she had gotten into dispute over car keys with her boyfriend who is also the father of her children. Officers located bullet holes in the wall of the lower level and spent casings at the scene. The suspect fled prior to police arrival and was identified. Approximately two hours later, the suspect turned himself in.

**Robbery**

**Date and Time:** April 22, 2021 at 3:26 pm

**Location:** 300 block of University Avenue West, Saint Paul

A victim was walking to her car when a male suspect drove up in an SUV and pulled her purse out of her hands. The suspect vehicle was taken in a strongarm carjacking in Minneapolis. The suspect vehicle was occupied by two male suspects and was accompanied by another vehicle with no plates.

**Robbery**

**Date and Time:** April 22, 2021 at 3:30 pm

**Location:** Chatsworth Street & Edmund Avenue, Saint Paul

A victim was robbed at gunpoint and punched by two male suspects. The victim reports a silver handgun with a laser was pointed at them. A perimeter was established with K9 tracking but so suspects were located.

**Weapons**

**Date and Time:** April 22, 2021 at 7:12 pm

**Location:** Jessie Street & Minnehaha Avenue, Saint Paul

Two males were reported at the intersection with long guns. The suspects exited a vehicle and were seen leaving on foot with the guns. The suspect vehicle was located unoccupied.
