



Notable Crimes Report

4/23/2021 – 4/30/2021

The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.

Counterfeit/Theft

Date and Time: April 2021

Location: 4600 block of Centerville Road, White Bear Lake

On several occasion during March and April, the same male suspect was seen at the business. He successfully passed counterfeit \$100 bills and attempted to pass another at a later date. The same suspect returned again, driving the same vehicle, and stole \$200 worth of merchandise.

Aggravated Robbery

Date and Time: April 23, 2021 at 11:19 pm

Location: 2700 block of Lakeshore Avenue, Little Canada

Deputies responded to a 9-1-1 call for a report of an aggravated robbery where a gun was implied. The male victim was walking when a vehicle occupied by two male suspects pulled up behind him and demanded money. The suspects attempted to take the victim's backpack and assaulted the victim. Deputies arrived at the scene where suspects fled on foot. Deputies set up a perimeter and K9 tracked with no success. No arrests were made.

Shooting

Date and Time: April 25, 2021 at 3:59 pm

Location: Payne Avenue & Magnolia Avenue, Saint Paul

Officers responded to a 9-1-1 call on a report of shots fired. Officers arrived and located a male victim with multiple gunshot wounds. Male victim was transported to the hospital. Multiple casings were recovered near the intersection.

Aggravated Assault/Shooting and Homicide

Date and Time: April 25, 2021 at 11:03 pm

Location: Jackson Street & Jessamine Street E, Saint Paul

Officers were dispatched to the 1200 block of Jackson Street for an assault call. Upon arrival, a 45-year-old male victim was located with one gunshot wound. The victim was transported to a local hospital where he later succumbed to his injuries.

Assault

Date and Time: April 27, 2021 at 6:05 pm

Location: Earl Street & Bush Avenue, Saint Paul

Officers responded to multiple 9-1-1 calls on reports of shots fired. A caller reported that a red vehicle fled through the alley at high rate of speed and its back window was shot out. Another caller reported that a silver vehicle was fleeing the area. Then a caller reported that the red vehicle was abandoned at the intersection with the windows shot out. Officers arrived on scene and located the abandoned vehicle. Officers found blood trail, checked the area, and impounded the vehicle.

Shots Fired

Date and Time: April 28, 2021 at 12:53 am

Location: Third Street and White Bear Avenue, Saint Paul

Officers were dispatched to the area of White Bear Avenue and Third Street on a report of shots fired. Officers recovered multiple spent bullet casings on scene. It is believed that two vehicles were possibly shooting at each other. At least one vehicle parked in the area was struck by gunfire. No injuries or deaths were reported.

Robbery

Date and Time: April 28, 2021 at 2:10 am

Location: 1300 block of Western Avenue

Saint Paul Officers assisted Minneapolis Police with locating a suspect and taking him into custody regarding a robbery/homicide that occurred earlier in Minneapolis. The suspect had been wanted for reportedly fatally shooting a store worker during an armed robbery in the Cedar-Riverside neighborhood.

Aggravated Assault/Shooting

Date and Time: April 28, 2021 at 3:09 am

Location: Raspberry Island

Officers responded to Raspberry Island for an assault where a female was shot in the leg. The victim was transported to the hospital by her boyfriend. Officers recovered spent shell casings on scene. The boyfriend told police he and his girlfriend had been hanging out at Raspberry Island. A vehicle pulled up next to them and someone got out of the driver's side and started shooting at them. The boyfriend told police he believed the shooting to be totally random. Officers later learned the victim and boyfriend were previously at Mounds Park and the boyfriend said he noticed the suspect vehicle had been following them earlier in the night.

Shots Fired

Date and Time: April 28, 2021 at 7:07 pm

Location: 1600 block of Hewitt Avenue, Saint Paul

Multiple callers reported up to 12 shots fired in the area and identified a vehicle leaving the area after the shots. Bullets from the gunfire damaged at least two homes and responding Officers found casings in the road and nearby yard.
