

## **Notable Crimes Report**

The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.

**Shots Fired** 

**Date and Time:** May 5, 2021 at 4:24 pm **Location:** Fairview & Hwy 36, Roseville

After a minor property damage accident between two parked vehicles, a male suspect fired 4-5 shots at the victim as he drove his vehicle away. Shell casings were found at the scene and the victims passenger side window was shattered.

**Shots Fired** 

**Date and Time:** May 7, 2021 at 11:17 am

**Location:** 1600 block of Edmond Ave, Saint Paul

As he returned home from work, the victim witnessed a male suspect litter in his yard and confronted him about it. The suspect pulled out a gun and fired one round. The suspect was located and arrested while still in possession of a handgun.

**Date and Time:** May 8, 2021 at 4:58 pm

**Location:** 900 block of Albemarle St., Saint Paul

An accidental shooting victim was dropped off at a local hospital. Follow up by Officers led them to an address on Albemarle where they located a weapon that was stolen.

**Date and Time:** May 10, 2021 at 9:30 pm

**Location:** 1000 block of Magnolia, Saint Paul

Three shots were fired at a residence through a window. Shell casings were found on the sidewalk. The gunfire was likely the result of hostility toward the victim's son who does not live at the address.

**Shots Fired** 

**Date and Time:** May 11, 2021 at 4:56 pm **Location:** Thomas & Grotto, Saint Paul

Two parties were shooting at each other outside of a bar with many bystanders in the area. A home on Grotto was struck by gunfire and several shell casings of two different calibers were found at the scene.

**Murder Warrant Arrest** 

**Date and Time:** May 12, 2021 at 4:30 am **Location:** Cub Foods, Arden Hills

Deputies were dispatched to a shoplifter. Deputies located a male suspect with merchandise from the store. Deputies were given a false name but were able to identify the suspect. During this call, Deputies found that the suspect had several warrants, including a third-degree murder warrant with a \$150,000 bail. The suspect was taken into custody.

**Date and Time:** May 12, 2021 at 2:48 pm

Location: 1000 block of Cumberland St., Saint Paul

A 9-1-1 caller reported that his friend had been shot in the stomach. A male suspect shot the victim

twice then fled the scene.

**Shots Fired** 

**Date and Time:** May 12, 2021 at 9:02 pm

**Location:** 600 block of Farrington St., Saint Paul

Multiple 9-1-1 callers reported between 6 to 15 shots fired coming from the intersection of Thomas & Western, people screaming, and a vehicle fleeing the area. When officers arrived on scene a witness reported that there was a large dispute. Two vehicles in the area were found to have bullet holes.

**Date and Time:** May 13, 2021 at 2:10 am

**Location:** 100 block of Litchfield St., Saint Paul

Multiple 9-1-1 callers reported over 20 shots fired in the area and described a vehicle that was possibly involved. A caller from Park Street reported several bullets penetrating their home. No injuries were sustained. Officers recovered shell casings from the scene.
