The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.

**Shots Fired** 

**Date and Time:** May 13, 2021 at 5:50pm

**Location:** 1100 block of Payne Avenue, Saint Paul

A group of individuals were outside a local business. Two males walked towards the group and starting shooting at the group. The two male shooters then fled from the scene. No one was injured.

Assault

**Date and Time:** May 15, 2021 at 8:43pm

**Location:** Maryland Avenue East and Hazelwood Street, Saint Paul

Squads responded to a call of two people being shot in the parking lot of a local business. Officers arrived on scene to find one male laying on the ground. Aide was rendered. A local hospital reported that a male with a gunshot injury was just dropped off at the Emergency Room. It was determined that this was the second male from this incident.

**Shots Fired** 

Date and Time: May 16, 2021 at 4:13 pm

**Location:** 1100 block of Margaret Street, Saint Paul

A 9-1-1 caller reported hearing a gunshot in the area. Witness told officers they heard the shot from the area of Earl and Beech. Officers located a spent rifle round at that intersection.

**Location:** 1100 block of Margaret Street, Saint Paul

An officer noticed a pickup truck parked at a gas pump with two mismatched licensed plates. One of the license plates was reported as stolen. As the officer was investigating, the driver of the truck approached the vehicle from the gas station. The driver then ran into the truck while being ordered to stop by the officer. The driver was able to start the vehicle. The officer broke the driver's side window open and was able to taze the driver. The suspect was still able to drive off in the truck. The officer suffered arm injuries from the broken car window. Neither the driver nor the truck were located.

Assault/DWI

**Date and Time:** May 19, 2021 12:02 am

**Location:** Centerville Road & Little Canada Road East, Little Canada

Deputies responded to a 9-1-1 call for a report of a suspicious vehicle. Deputies arrived and found an occupied vehicle on the grass of a business backed into a tree. A female occupant of the vehicle refused to identify herself and deputies conducted standard field sobriety tests. The suspect displayed signs of intoxication. When deputies went to handcuff the female for DWI (driving while impaired), she spit at the deputies' face. The female was arrested and booked for assault and DWI.

**Aggravated Robbery** 

**Date and Time:** May 18, 2021 at 10:00 pm

**Location:** 1300 block of University Avenue, Saint Paul

An off-duty officer working at Target witnessed three individuals attempting to use multiple credit cards. The suspects also had a large amount of cash in their hands. The officer obtained license plate information of the suspects' vehicle and found that the vehicle had been involved in two armed robberies earlier in the evening. Multiple officers arrived on scene and the suspects were taken into custody. Officers recovered two firearms from the vehicle. Officers also located evidence from the earlier robberies.

**Shots Fired** 

**Date and Time:** May 19, 2021 at 1:02 am

**Location:** 1400 block of White Bear Avenue North, Saint Paul

Officers located eight spent casings at White Bear Ave/Sherwood, near Sherwood lounge. A witness saw two male suspects leave the bar just prior to hearing shots being fired. Suspects fled from officers. The vehicle was later located unoccupied at Larpenteur & Beebe. The suspects were not located.

**Bank Robbery** 

**Date and Time:** May 20, 2021 at 11:16 am

**Location:** 100 block of 5th Street, Saint Paul

A male suspect entered the US Bank Building and robbed the bank using a note that implied a

weapon. The suspect then fled the scene through the skyway.
