



# Notable Crimes Report

## Shots Fired

**Date and Time:** May 28, 2021 at 1:33 am

**Location:** 1100 block of Grand Avenue, Saint Paul

Officers responded to several shots being fired inside and outside of a local business. There were no injuries. There was visible damage to the building from gunshots.

## Suspicious Activity

**Date and Time:** May 28, 2021 at 10:07 pm

**Location:** Sycamore Street East and Jackson Street, Saint Paul

Security staff reported a vehicle driving around in the cemetery without its headlights on. Officers responded and the vehicle led them on a low speed pursuit. Deputies were able to stop the vehicle on Interstate 35-E and apprehend the suspect. A one-year old child was discovered in the backseat by law enforcement after the vehicle was stopped.

## Recovered Property

**Date and Time:** May 29, 2021 at 1:14 am

**Location:** 1000 block of Suburban Avenue, Saint Paul

Officers located a stolen vehicle that was stolen out of Minneapolis. The vehicle was taken from the victim via carjacking. A male was currently in the vehicle when the officer located the car. Officers subsequently arrested the man.

## Assault

**Date and Time:** May 29, 2021 at 1:25 pm

**Location:** Regions Hospital

Officers were dispatched to Regions Hospital for an assault. Officers then learned a male had suffered a gunshot wound to the head. The man had initially told Regions staff that he was injured from falling down.

## Shots Fired

**Date and Time:** May 29, 2021 at 8:25 pm

**Location:** 800 block of Rice Street, Saint Paul

Officers heard gunshots near Rice and Manitoba. Casings were located near Super Foods. A caller reported a male had walked into the corner store with a gun and was arguing with a second man.

## Assist Other Agency

**Date and Time:** May 29, 2021 at 11:40 pm

**Location:** Pascal Street North and Interstate 94, Saint Paul

Minneapolis Police pursued a homicide suspect vehicle into Saint Paul. Stop sticks were deployed on Interstate 94. The suspect vehicle exited onto Lexington. At Central and Oxford, the occupants stopped the car and fled on foot. All parties were apprehended. A crowd started to form around the incident. Minneapolis requested Saint Paul to assist with crowd control.
