



Notable Crimes Report

The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.

Recovery of Stolen Vehicle

Date and Time: June 6, 2021 at 7:08 pm
Location: University Ave W and Grotto St N, Saint Paul

A sedan was taken via carjacking on June 5. On June 6, while on patrol squads located the sedan going westbound on University near Grotto. A traffic stop was initiated. Six juveniles were inside the stolen vehicle. The juveniles were identified and released to legal guardians.

Escape from Kidnapping

Date and Time: June 6, 2021 at 10:51 pm
Location: 1300 block of Burke Ave E, Roseville

Caller reported a female was on their deck and yelling for help. The female stated she had just jumped out of a vehicle after having been kidnapped. The occupants of the vehicle had a gun.

Robbery

Date and Time: June 6, 2021 at 11:53pm
Location: 700 block of Larpenteur Ave E, Saint Paul

The caller was attempting to sell a speaker. Two males came to the address with a gun and took the speaker.

Disorderly Conduct

Date and Time: June 8, 2021 at 4:22pm
Location: 1600 block of Edmund Ave, Saint Paul

A 9-1-1 caller confronted a male breaking glass in the alley. The male retrieved a gun from his car and pointed it at the 9-1-1 caller. The male then went into his residence. Officers arrived and took the male into custody.

Robbery-Strong Arm

Date and Time: June 9, 2021 at 9:23 pm
Location: 500 block of 4th St E, St. Paul

Officers responded to the 500 Block of E 4th Street on a robbery report. The victim told police he met a female through mutual friends on Snapchat and went to the location to meet with her for a date and the female told the victim to bring his guitar. The victim said he arrived at the location and began to walk down a footpath in the area when he was jumped (punched in the head and body) from behind. The victim told police as he was being attacked, he fought back then another suspect joined the fight and began to choke him. At one point the second suspect grabbed the victim's guitar and started hitting him with it, causing the guitar to smash. The victim said during the robbery the two suspects were yelling insults at him.

Aggravated Assault

Date and Time: June 8, 2021 a 6:30 pm

Location: 1100 block of Margaret St, St. Paul

Officers were sent to the 1000 block of Margaret St. for a gun pointing incident. Multiple callers reported a group of juveniles pointing a gun at them. Officers spoke to one of the complainants, who said a group of juveniles got into a dispute with her and her children where one of the juveniles produced a gun and pointed it at them. Police determined the juvenile suspect who produced the gun was no longer on scene. Officers did locate a replica airsoft firearm in a nearby garbage can.

Arson (Vehicle Fire)

Date and Time: June 9, 2021 at 12:52 am

Location: 50 block of White Bear Ave N, Saint Paul

Multiple callers reported a vehicle on fire. The St. Paul Fire Department extinguished the vehicle fire. Officers learned the burned vehicle had been reported stolen out of Minneapolis. Witnesses and neighbors in the area provided police with possible suspect information.

Armed Robbery

Date and Time: June 8, 2021 at 5:46pm

Location: 1300 block of Rice St, Saint Paul

A victim was robbed at gunpoint by two male suspects. A male had a gun and held it to the victim's head, then pistol-whipped him. Both suspects fled on foot before officers arrived. Officers deployed a K9 however the suspect was not located.

Stolen Vehicle Recovered / Fleeing

Date and Time: June 8th, 2021 at 10:58pm

Location: 200 block of Wilkin St, Saint Paul

Officers approached a parked stolen vehicle, which was occupied by two male juvenile suspects. The stolen vehicle took off and crashed into two parked vehicles on the street. Two suspects jumped out of the vehicle leaving the vehicle in drive, causing it to crash into the officer's vehicle. The suspects were apprehended and taken into custody.

Shots Fired/Assault

Date and Time: June 9, 2021 at 3:45pm

Location: Como Ave & Midway Parkway, Saint Paul

Multiple callers reported hearing at least five shots fired from a vehicle occupied by five suspects. A male victim who had been shot was then seen limping near the Como fire pits. Officers located a vehicle with five bullet holes and located the victim in a separate vehicle.
