



# Notable Crimes Report

*The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.*

## Shots Fired

**Date and Time:** July 17, 2021 at 3:00 pm

**Location:** Hamline Ave North and University Ave West, Saint Paul

Officers responded to a shots fired call in the area of Hamline and University. An orange Dodge Charger was reported speeding through the area and shooting a firearm. The vehicle was later located in an underground parking garage. No injuries were reported.

## Shots Fired

**Date and Time:** July 18, 2021 at 1:02 am

**Location:** Klainert St and Timberlake Rd, Saint Paul

Officers responded to a call of gunshots and fireworks being fired. Once on scene, officers found a male in the parking lot. The man was in possession of a handgun. Several spent casings were on the ground. The male was arrested.

## Fight

**Date and Time:** July 18, 2021 at 1:07 am

**Location:** 2000 block of Rice St, Little Canada

Deputies were dispatched to a fight call with approximately 100 people fighting at an event. Deputies received additional assistance from Roseville Police. The crowd was dispersed.

## Assist Other Agency

**Date and Time:** July 19, 2021 at 12:31 am

**Location:** 1500 block of Race St, Saint Paul

White Bear Lake Police issued a pickup and hold for a suspect. The male was wanted for second degree assault with a dangerous weapon (felony). Saint Paul officers located the male and arrested him. The male was also later charged with fifth degree criminal sexual conduct in the same incident.

## Assault

**Date and Time:** July 19, 2021 at 1:42 am

**Location:** 1400 block of Van Buren Ave, Saint Paul

Residents reported seeing two vehicles circling the neighborhood. Shortly after, the residents heard sawing noises and believed someone was attempting to steal a catalytic converter. The residents then saw a male underneath a vehicle in the alley. When the residents approached the suspect under the car, he pointed a gun at the residents. The male then got into his vehicle and fled the scene.

## Motor Vehicle Pursuit

**Date and Time:** July 19th, 2021 at 3:26pm

**Location:** Owasso St / Harriet Ave, Shoreview

Deputies got into a pursuit of a vehicle that fled from a traffic violation, where the suspect nearly struck a pedestrian in the middle of the crosswalk. Two PITs were attempted, which lead the end of the pursuit. The driver got out of the vehicle and fled on foot and was chased down by the deputies. The suspect driver was taken into custody. Two squads were damaged.

## Assist Fire Agency

**Date and Time:** July 19th, 2021 at 11:24pm

**Location:** 4000 block of Chatsworth St N, Shoreview

Deputies responded to a report of a crane being on fire in the construction area. Upon arrival, deputies could see flames and smoke coming from the crane. Firefighters arrived on scene and put fire out. No one was injured.

## Shots Fired

**Date and Time:** July 19, 2021 at 5:28pm

**Location:** Beech St. and Cypress St., Saint Paul

Callers reported seeing two people in a sedan shooting at two people on foot near Beech and Cypress. The sedan was later located and the suspects detained.

## Fleeing in Motor Vehicle

**Date and Time:** July 21, 2021 at 8:88 am

**Location:** Highway 61 & Co. Rd. E, Gem Lake

Squads assisted North Branch Police after a stolen vehicle fled from them and crashed at Hwy 61 and County Road E East. The driver fled on foot and then entered a business. A witness confronted him and pushed him outside where law enforcement was waiting for him. The suspect was booked on a felony Ramsey County warrant for fleeing police in a motor vehicle and a new charge of felony fleeing police in a motor vehicle.

**Location:** 700 block of Cottage Ave., Saint Paul

A caller reported shots fired and three suspects running into the parking lot at Johnson High School. Officers recovered evidence of gunfire in the area.
