Kenneth Earl Crew Age 56 • Saint Paul

Kenneth Earl Crew, age 56 of Saint Paul, is a career criminal as defined by Minnesota State Statute. Kenneth Crew has the following warrant issued in Ramsey County:

 Probation Violation Warrant for Misdemeanor Theft out of Ramsey County

On April 04, 2023, Kenneth Crew plead guilty to the charge of Theft-Take/Use/Transfer Movable Prop – No Consent and was sentenced to 90 Days with 2 days to serve and 88 days stayed. Kenneth Crew also was sentenced to Supervised Probation of 1 Year.

On May 20th, 2022, Ramsey County Probation issued a warrant for Kenneth Crew for failure to contact Ramsey County Probation within the first 30 days of probation. Currently the whereabouts of Kenneth Crew is unknown.
