

Ramsey County Sheriff's Office Serious/Career Offender Accountability & Rehabilitation (SCOAR)


This summary includes public information related to the charging, bail conditions, prosecution, sentencing, and probation of serious and career offenders to ensure accountability and transparency of the justice system in keeping the community safe.

Oscar Delacruz Age 33 • Saint Paul

Oscar Delacruz, age 33 of Saint Paul, is a career criminal as defined by Minnesota State Statute. Delacruz has the following active/open cases in Ramsey County:

- 1 Criminal Damage to Property case out of Saint Paul
- 4 theft cases out of Saint Paul, Vadnais Heights and Maplewood
- 2 fleeing in a motor vehicle cases out of Roseville and Mounds View
- 1 motor vehicle theft case out of Mounds View
- 2 assault cases out of Saint Paul

On March 19, 2021, Delacruz was booked on identity theft, motor vehicle theft, criminal damage to property and fleeing in a motor vehicle. The Ramsey County Attorney's Office recommended bail be set at \$50,000. Bail was set at \$40,000 by Judge Sheu. Delacruz is awaiting court/bail; he is scheduled to appear before Judge Stephenson on May 21, 2021. Delacruz also has a warrant for drugs out of Washington County and a warrant for fleeing in a motor vehicle out of Hennepin County.
