

Ramsey County Sheriff's Office Serious/Career Offender Accountability & Rehabilitation (SCOAR)

This summary includes public information related to the charging, bail conditions, prosecution, sentencing, and probation of serious and career offenders to ensure accountability and transparency of the justice system in keeping the community safe.

Mitchell Jay Landa Age 56 • Saint Paul

Mitchell Jay Landa, age 56 of Saint Paul, is a career criminal as defined by Minnesota State Statute. Landa has the following active/open cases in Ramsey County:

- 1 Drug case out of Faribault
- 1 Theft case out of Woodbury

On February 13, 2023, Mitchell Landa was booked in Rice County on Drugs 3rd Degree. Mitchell Landa was released on his personal recognizance and given a court date of April 12, 2013. Mitchell Landa failed to appear for his court date and a new warrant was issued. On May 5, 2023, Mitchell Landa was arrested and held in jail until May 12, 2023. Mitchell Landa was held until a \$10,000 Bond was posted and he was released with conditions. On May 15, 2023, Mitchell Landa posted bond and had a hearing on May 17, 2023, that he appeared. On July 18, 2023, Rice County issued a warrant for not appearing for court, and the warrant is for Possession of Drugs 3rd Degree and has a bail of \$100,000.



On May 4, 2023, Mitchell Landa was booked in the Washington County Jail for Misdemeanor Theft and a warrant out of Rice County. On May 5, 2023, Mitchell Landa was released to Rice County and was given a future court date of June 12, 2023. Mitchell Landa attended the June 12, 2023, and has a future court date of August 17, 2023.
