



This summary includes public information related to the charging, bail conditions, prosecution, sentencing, and probation of serious and career offenders to ensure accountability and transparency of the justice system in keeping the community safe.

**Gregory Robert McCarthy
Age 41 • Saint Paul**

Gregory Robert McCarthy, age 41 of Saint Paul, is a career criminal as defined by Minnesota State Statute. McCarthy has the following active/open cases:

- Felony Theft case out of Prior Lake
- 1st Degree Burglary case out of Prior Lake
- Possession of Drugs 3rd Degree out of Prior Lake

On April 13, 2023, Gregory McCarthy was arrested by Prior Lake PD for Possession of Drugs 3rd Degree, Receiving Stolen Property, Possession of Burglary or Theft Tools, Fleeing a Peace Officer by a Means Other Than a Motor Vehicle, Obstruct Legal Process. McCarthy then claimed that he had ingested drugs and was taken to a hospital. McCarthy was then released to the hospital, and he fled the hospital.

Once McCarthy was at the hospital, and at the hospital, officers released him. McCarthy then fled the hospital, located a bicycle and road until he found a homeowner who was going to help him. McCarthy was only wearing red boxers and McCarthy asked the homeowner if he could have a shirt. When the homeowner went in, McCarthy snuck into the house, grabbed the keys to the homeowner's vehicle, and drove away.

On April 14, 2022, McCarthy was arrested in Maplewood in the stolen Shakopee vehicle.

As of September 22, 2023, Gregory McCarthy has an active Felony Warrant out of Washington County for a Probation Violation Warrant and a Dakota County Warrant for Receiving Stolen Property.
