

Ramsey County Sheriff's Office Serious/Career Offender Accountability & Rehabilitation (SCOAR)

This summary includes public information related to the charging, bail conditions, prosecution, sentencing, and probation of serious and career offenders to ensure accountability and transparency of the justice system in keeping the community safe.

James Matthew McCarty Age 55 • Saint Paul

James Matthew McCarty, age 55 of Saint Paul, is a career criminal as defined by Minnesota State Statute. McCarty has the following active/open cases in Ramsey County:

- Possession of Ammunition case out of North St. Paul
- Misdemeanor Theft case out of West St. Paul

On August 12, 2022, James McCarty was investigated by North St. Paul Police Department for Possession of Ammunition. On October 28th, a Warrant was issued and was cleared by arrested on January 21, 2023. On January 23, 2023, James McCarty was seen on the first appearance in the case and was released with conditions. On March 9, 2023, a bench warrant was issued and it was cleared on June 03, 2023 when James McCarty was transferred from Dakota County to the Ramsey County LEC. On June 16, 2023 James McCarty was released from the LEC on a Conditional Release with a Court Date of July 13, 2023. James McCarty failed to appear in court for his Ramsey County and Dakota County Cases and new warrants have been issued. On August 7, 2023, James McCarty was arrested by Roseville PD on his warrants and a new charge of Possession of Stolen Property.
