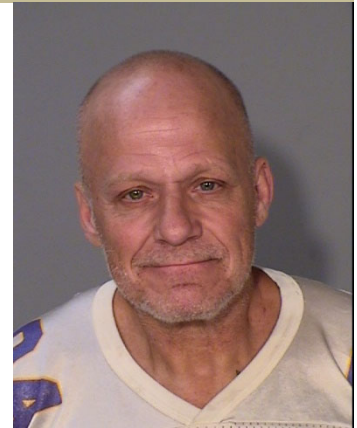


This summary includes public information related to the charging, bail conditions, prosecution, sentencing, and probation of serious and career offenders to ensure accountability and transparency of the justice system in keeping the community safe.

**Richard James O'Reilly
Age 60 • Saint Paul**

Richard James O'Reilly, age 60 of Saint Paul, is a career criminal as defined by Minnesota State Statute. Richard O'Reilly has the following active/open cases:

- Misdemeanor Theft case out of Mille Lacs County
- Driving After Cancellation – Inimical to Public Safety(IPS) case out of Fridley
- Threats of Violence case out of Fridley



On October 1, 2022, Fridley Officers stopped Richard O'Reilly with a stolen motorcycle. Richard O'Reilly stated to the Officer that he had the vehicle from another person and that he was IPS. Richard O'Reilly was released on 10/4/2022 from the Anoka County Jail. On April 7, 2023, Anoka County issued a warrant for the arrest of Richard O'Reilly, and he was arrested on May 9, 2023, and booked into the Anoka County Jail. On May 23, 2023, Richard James O'Reilly was booked into the Washington County Jail. Richard O'Reilly next court date is August 22, 2023.
