Executive Summary

Ramsey County, through its guiding goals of cultivating economic prosperity and enhancing access to opportunity for business, places a high value on inclusiveness in contracting. The CERT Small Business Enterprise (SBE) program provides opportunities for certified small businesses to participate in Ramsey County operational procurements.

Additionally, Ramsey County supports Minnesota Statutes 363A.37 and Administrative Rule 5000.3520 which gives the Commissioner of the Minnesota Department of Human Rights the authority to set goals for state funded construction projects. Contractors on state-funded projects will be subject to goals for minorities and women on government funded projects that more accurately reflect Minnesota's increasing diversity. These goals are enforced by the Minnesota Department of Human Rights for all state funded construction projects. Ramsey County also applies Minnesota's workforce diversity goal to Property Management construction projects not funded by the state. Goal Percentages for Hennepin County and Ramsey County Area, including all cities and towns within the boundaries of Hennepin County and Ramsey County, are 32% minority and 6% women (all trades)

In 2015, Ramsey County exceeded our estimated 2016 and 2017-18 Performance Measures for both # of CERT SBE vendors and Total CERT SBE Spending as reported in the 2017 Performance Measures and Supplemental Budget¹. Ramsey County increased the number of CERT SBE engagements from 125 in 2014 to 170 in 2015. Additionally, we increased SBE spend by \$5.89 million in 2015, paying CERT SBEs \$15,732,996 in 2015 compared to \$9,839,517 in 2014.

Parks and Recreation allocated \$1,367,963, more than 37% of their project funds, to CERT SBE construction contractors. Property Management directed \$7,723,495, more than 54% of their project funds, to CERT SBE construction contractors. Additionally, Property Management supported and in several projects, exceeded Minnesota's workforce diversity good faith effort goals for construction projects. For example, the deconstruction of the Riverfront Properties achieved 43.03% minority participation and 9.98% female participation in 2015.


CERT Payments by County (2012-2015)



Parks & Recreation Department offers several opportunities to CERT SBE vendors, including

- Administrative supplies and services (printing, software, office supplies)

Parks & Recreation supports the inclusiveness in contracting effort through the following strategies

Reported Results

- 1. In 2015, Parks & Recreation allocated \$1,415,681, or more than 22%, of its total discretionary spending to CERT SBE vendors. The department directly contracted with 26 SBE vendors, and several more were involved on department projects as tier contractors.
- 2. The Parks & Recreation Planning Division, which is responsible for managing the Department's construction, maintenance, planning, and repairs, allocated \$1,367,963, or more than 37%, of its project funding to CERT SBE vendors.

- 1. During the period January 1, 2015 December 31, 2015, the Property Management department directed more than 54% of its total construction project value to vendors in the CERT program. That is \$7,723,495 to help grow CERT vendors to make them stronger, more profitable and increase job opportunities.
- 2. The Property Management department attributed \$1,455,475 of our total department discretionary spending to CERT Vendors in 2015. This represents 17.7% of our discretionary spending. Additionally, Property Management increased the number of CERT vendors utilized



by 16% over 2014, thus involving more CERT vendors in the day-to-day operations of Property Management.

- 3. In terms of Workforce Diversity, the County continues to establish and enforce goals on larger projects.
