#### **Call to Order**

Chair Chad Kulas called the meeting to order at 2:32 p.m.

# Announcements

Channon's appointment will be considered by the County Board soon.

# New Member Introductions and Break Out Session

Aasheim, Blake, Duffy, McIntosh and Stevens introduced themselves. Meeting attendees then broke into small groups for discussion about the following topic: Show the seventh photo saved on your phone and explain it.

### **One-Stop Operator (OSO) Consortium Update**

Guetzkow, Becker, and Larson provided an update on the work of the OSO which is focused on strengthening collaborative efforts among the partners to better link job seekers and businesses. The presentation included:

- an overview of the One-Stop system.
- a review of work done in 2020 around COVID and civil unrest response, developing a partner resource and hosting convenings and trainings for system partners
- an outline of the 2021 work plan, including forming two subcommittees and hosting partner convenings and trainings
- a preview of labor market reports that will be released soon

# Minnesota Registered Apprenticeship Program

Aiken, Director of Labor Standards and Apprenticeship with the MN Department of Labor & Industry (MNDLI), provided a presentation on Apprenticeship Minnesota, Minnesota's registered apprenticeship program. There are currently 11,000 active apprentices across the state; over 20% are people of color and 90% are in the construction industry. Federal funding is being used to increase the number of apprenticeships, support apprentice diversity, and integrate apprenticeship into state workforce development

strategies. Under the five-year Minnesota Apprenticeship Initiative, registered apprenticeships in Agriculture, Manufacturing, Healthcare, Information Technology and Transportation have been expanded. This and the Minnesota Apprenticeship Expansion (APEX) Initiative have been successful in introducing apprenticeships to females, people of color, youth and veterans. Aiken asked WIB members to consider ways MNDLI can deepen its partnership and engagement to better serve job seekers and employers in Ramsey County. Diversity and inclusion training sessions are available for apprentices online. A list of employers and sponsors is also on the MNDLI website. The slide deck will be sent to all members.

#### CARES Partnership: High School for the Recording Arts.

Becker introduced Herold, an instructor at the High School for the Recording Arts (HSRA) and CEO/Founder of the recording label, Rock the Cause. Herold shared information about the student population, most of whom are BIPOC and many identify as homeless, and the recording industry programs and work experiences offered at the school. He also talked about the CARES funding the school received from Ramsey County to support student wages and provide equipment so students could continue to learn virtually during COVID. Stone, an HSRA student, talked about the value and impact the job skills and work opportunities have had on her life and career plans. Herold stated that HSRA is in need of additional long-term funding to expand opportunities for students. He invited the WIB to listen to an upcoming student created radio show airing on WFNU, featuring the Ramsey County program.
